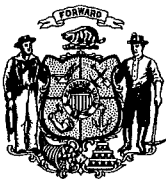

**SENATE AMENDMENT ,
TO SENATE BILL 179**

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 7, line 8: after “(c),” insert “(cm),”.
- 3 **2.** Page 7, line 17: after that line insert:
- 4 “(cm) Within 2 hours of removing a vehicle from private property under par. (b)
- 5 or (c), the towing service that removed the vehicle shall do all of the following:
- 6 1. Inform the primary local law enforcement agency that has jurisdiction over
- 7 the area from which the vehicle was removed that the vehicle has been removed and
- 8 provide the law enforcement agency with the registration number located on the
- 9 vehicle’s registration plate.
- 10 2. Request that the law enforcement agency under subd. 1. attempt to
- 11 determine a phone number to contact the owner of the removed vehicle.
- 12 3. If a local law enforcement agency provides the towing service with a phone
- 13 number under subd. 2., contact the owner of the vehicle to inform the owner that the

1 owner's vehicle has been removed and to provide the owner with information about
2 how the vehicle may be retrieved.”

3 **3.** Page 8, line 5: after “subsection” insert “and rules to facilitate the
4 notification requirements under par. (cm)”.

5 **4.** Page 21, line 3: after “(c),” insert “(cm),”.
