At the locations indicated, amend the bill as follows:

1. Page 5, line 1: delete the material beginning with "that line" and ending with page 6, line 22 and substitute:

"Section 17. 66.01035 of the statutes is created to read:

66.01035 Ordinances affecting the rights and responsibilities of residential landlords and tenants. No city, village, town, or county may enact an ordinance that affects the rights or responsibilities of a residential landlord or tenant unless the ordinance is in conformity with state law or the ordinance preserves or promotes public health or safety.

66.0104 of the statutes is repealed.".
