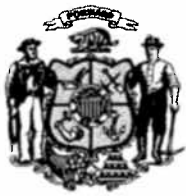

2013 ASSEMBLY BILL 359

September 13, 2013 - Introduced by Representatives SWEARINGEN, CZAJA, TITTL, SANFELIPPO, MARKLEIN, BROOKS, T. LARSON, BERNIER, MURTHA, KLEEFISCH, PRIDEMORE and A. OTT, cosponsored by Senators TIFFANY and GROTHMAN. Referred to Committee on Natural Resources and Sporting Heritage.

1 **AN ACT** *to amend* 26.08 (2) (a); and *to create* 26.08 (2) (e) of the statutes;
2 **relating to:** authorizing the Department of Natural Resources to lease state
3 forest land to the Boulder Junction Shooting Range for terms not exceeding 30
4 years.

Analysis by the Legislative Reference Bureau

Under current law, with certain exceptions, the Department of Natural Resources (DNR) may lease state park land or state forest land for terms not exceeding 15 years. This bill authorizes DNR to lease state forest land located in the town of Boulder Junction to the Boulder Junction Shooting Range for terms not exceeding 30 years.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

5 **SECTION 1.** 26.08 (2) (a) of the statutes is amended to read:
6 26.08 (2) (a) Except as provided under pars. (b) to ~~(d)~~ (e), the department may
7 lease state park land or state forest land for terms not exceeding 15 years.
