TO ASSEMBLY BILL 11**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 19: after that line insert:

3 “(e) School premises if any of the following apply:

4 1. The school is vacant or closed.

5 2. The students who are enrolled in the school are not present.

6 (f) A person who is in an area of the school premises that may not be accessed  
7 by students who are enrolled in the school.”
