

1           (c) The trustee has a beneficial interest in the first trust unless the 2nd trust  
2 is a trust for an individual with a disability and the trustee's only beneficial interest  
3 in the first trust is as a remainder beneficiary.

4           (d) The appointment of assets to a 2nd trust would impair currently exercisable  
5 withdrawal rights of a beneficiary of the first trust and one of the following applies:

6           1. The withdrawal rights were granted to the beneficiary in a manner designed  
7 to allow contributions subject to the withdrawal rights to qualify for the federal gift  
8 tax annual exclusion.

9           2. The terms of the 2nd trust would impair gifts previously made to the first  
10 trust from qualifying for the federal gift tax annual exclusion under section 2503 of  
11 the Internal Revenue Code.

12           (e) The appointment of assets to the 2nd trust would violate a rule against  
13 perpetuities applicable to the first trust or suspend a trustee's power of alienation  
14 over assets of the first trust in a manner that would cause all or a portion of the 2nd  
15 trust to be void.

16           (f) The appointment of assets to the 2nd trust under sub. (2) would impair the  
17 essential purpose of a trust for an individual with a disability.

18           (4) PERMISSIBLE TERMS OF 2ND TRUST. (a) Subject to pars. (b) to (d) and subs. (2),  
19 (3), and (5), the trustee of the first trust may create a 2nd trust instrument that  
20 includes terms that are intended to achieve any purpose, including terms that are  
21 intended to do any of the following:

- 22           1. Correct a drafting error in the first trust.  
23           2. Clarify potentially ambiguous terms contained in the first trust.  
24           3. Change the age of distribution to a beneficiary of the first trust.  
25           4. Extend the duration of the first trust.

- 1           5. Protect the interests of a beneficiary of the first trust, including protecting  
2 the beneficiary from self-destructive behavior.
- 3           6. Allow the trustee of the 2nd trust to transfer trust assets to a community  
4 trust. In this subdivision, “community trust” means a master trust that is  
5 established and managed by a nonprofit organization that maintains sub-accounts  
6 for individual beneficiaries that each satisfy the definition of a trust for an individual  
7 with a disability.
- 8           7. Add or remove a spendthrift trust provision to the first trust.
- 9           8. Modify investment provisions contained in the first trust, including those  
10 relating to permissible investments, use of investment advisors, directed trust  
11 property, or self-dealing transactions.
- 12           9. Change a present or future trustee of the first trust, including by defining  
13 the method by which a trustee or cotrustee may be appointed or removed and  
14 replaced.
- 15           10. Appoint a trust protector of the 2nd trust and define the powers of the trust  
16 protector.
- 17           11. Appoint a directing party of the 2nd trust and define the powers of the  
18 directing party.
- 19           12. Change the principal place of administration of the first trust.
- 20           13. Change the governing law of the first trust.
- 21           14. Allow for the division of the first trust into 2 or more trusts.
- 22           15. Allow for the merger of the first trust with one or more trusts.
- 23           16. Add or modify an exculpatory provision for a trustee, trust protector, or  
24 directing party.

1           17. Obtain desirable tax treatment, as determined by the trustee of the first  
2 trust, or to avoid adverse tax consequences, as determined by the trustee of the first  
3 trust, including provisions relating to grantor trust status under sections 671 to 679  
4 of the Internal Revenue Code.

5           18. Modify a power in the first trust to invade income and principal.

6           19. Modify or eliminate a general or special power of appointment in the first  
7 trust.

8           (b) The trust instrument of the 2nd trust may include terms granting a  
9 beneficiary a general or special power of appointment only if the trustee of the first  
10 trust has the absolute power to invade income and principal.

11           (c) 1. The trust instrument of the 2nd trust may include terms that are intended  
12 to change terms of the first trust that are applicable to a beneficiary who is an  
13 individual with a disability only if the purpose of the change is to allow the  
14 beneficiary to qualify or continue to be qualified to receive benefits under a  
15 government program.

16           2. Subdivision 1. applies regardless of whether the first trust includes specific  
17 or ascertainable standards for distribution.

18           (d) The trust instrument of the 2nd trust may include a term that adopts or  
19 expands an exculpatory provision relating to the trustee only if one of the following  
20 applies:

21           1. Any trustee of the first trust who would benefit from the adoption of the term  
22 in the 2nd trust abstains from the consideration and adoption of the term and the  
23 trustees of the first trust who would not benefit from the adoption of the term adopt  
24 the trust instrument of the 2nd trust.

25           2. A court approves the trust instrument of the 2nd trust.

1           (5) PROCEDURAL MATTERS. (a) A trustee shall appoint assets to a 2nd trust under  
2 sub. (2) by an instrument in writing that is signed and acknowledged by the trustee  
3 and shall include the written instrument with the records of the first and 2nd trusts.  
4 A trustee may appoint assets to a 2nd trust under sub. (2) upon notice, without court  
5 approval, under the procedure described in par. (b), or with court approval, under the  
6 procedure described in par. (c).

7           (b) 1. If a trustee chooses to proceed without a court order, the trustee shall give  
8 notice of the manner in which the trustee intends to appoint assets to a 2nd trust  
9 under sub. (2) to all of the following:

- 10           a. The qualified beneficiaries of the first trust.  
11           b. Each trust protector appointed under the terms of the first trust.  
12           c. Each directing party appointed under the terms of the first trust.  
13           d. The settlor of the first trust, if living.

14           2. To satisfy the trustee's notice obligation under this paragraph, a trustee shall  
15 provide each person entitled to receive notice under subd. 1. all of the following:

- 16           a. A copy of the proposed written instrument under which the trustee will  
17 appoint assets to a 2nd trust.  
18           b. The proposed effective date of the appointment.  
19           c. A copy of the trust instrument of the first trust.  
20           d. A copy of the trust instrument of the 2nd trust.

21           3. A trustee may not appoint assets to the 2nd trust until 30 days after the  
22 trustee provides notice as required under this paragraph unless every person who  
23 is entitled to receive notice under subd. 1. waives the 30-day notice period by  
24 delivering a signed written instrument to the trustee. A person's waiver of the

1 30-day notice period does not constitute that person's consent to the trustee's  
2 appointment of assets to a 2nd trust.

3 4. If a person entitled to receive notice under subd. 1. delivers a written  
4 objection to the trustee before the effective date of the appointment of assets to a 2nd  
5 trust, the trustee may not appoint the assets to a 2nd trust, as specified in the  
6 trustee's notice, without obtaining court approval under par. (c) unless the written  
7 objection is withdrawn.

8 5. If the trustee does not receive a written objection from any person entitled  
9 to receive notice under subd. 1. before the effective date of the appointment of assets  
10 to the 2nd trust or all written objections to the proposed appointment of assets to the  
11 2nd trust are withdrawn, the trustee may appoint the assets to a 2nd trust, as  
12 specified in the notice.

13 (c) 1. If a trustee chooses to proceed with court approval, including after  
14 receiving a written objection to a proposed appointment of assets, the trustee shall  
15 petition a court to approve a proposed appointment of assets to a 2nd trust under sub.  
16 (2). The trustee shall provide notice of the petition to all qualified beneficiaries of the  
17 first trust, each trust protector appointed under the first trust, each directing party  
18 appointed under the first trust, and to the settlor of the first trust, if living. The  
19 trustee shall include in the notice of the petition the proposed effective date of the  
20 appointment of assets to a 2nd trust. The trustee shall also provide to each person  
21 who is entitled to receive notice under this paragraph a copy of the proposed  
22 instrument under which the trustee will appoint assets to a 2nd trust, the proposed  
23 effective date of the appointment, a copy of the trust instrument of the first trust, and  
24 a copy of the trust instrument of the 2nd trust.

1           2. If a person who is entitled to receive notice under subd. 1. files an objection  
2 with the court, in determining whether to grant or deny a petition under subd. 1., the  
3 court shall consider all of the following:

4           a. The purpose of the proposed appointment of assets under sub. (2).

5           b. The reasons for any objection made by a person entitled to receive notice  
6 under subd. 1.

7           c. Changes in circumstances that have occurred since the creation of the first  
8 trust.

9           d. Whether the appointment of assets under sub. (2) complies with the  
10 requirements of this section.

11           3. If no person who is entitled to receive notice under subd. 1. files an objection  
12 with the court or any objection that has been filed with the court is withdrawn, the  
13 court shall enter an order approving the appointment of assets under sub. (2) as set  
14 forth in the trustee's notice unless the court determines that the appointment of  
15 assets does not comply with the requirements of this section.

16           **(6) SUBSEQUENTLY DISCOVERED ASSETS.** (a) The appointment of all of the assets  
17 of the first trust in favor of the trustee of the 2nd trust includes subsequently  
18 discovered assets otherwise belonging to the first trust and assets paid to or acquired  
19 by the first trust subsequent to the appointment in favor of the 2nd trust.

20           (b) Except as otherwise provided by the trustee of the first trust, the  
21 appointment of part but not all of the assets of the first trust in favor of the 2nd trust  
22 does not include subsequently discovered assets belonging to the first trust or assets  
23 paid to or acquired by the first trust subsequent to the appointment in favor of the  
24 2nd trust, which remain the assets of the first trust.

1           (7) LIABILITY. (a) This section does not create or imply a duty on a trustee to  
2           appoint assets to a 2nd trust under sub. (2). A trustee that does not appoint assets  
3           to a 2nd trust under sub. (2) is not liable for the failure to do so.

4           (b) A trustee who appoints assets to a 2nd trust under sub. (2) is not liable to  
5           any beneficiary for any loss related to the appointment unless the trustee did not  
6           appoint the assets in good faith. This paragraph applies regardless of whether the  
7           trustee proceeds under sub. (5) (b) or (c).

8           (8) MISCELLANEOUS PROVISIONS. (a) The appointment of assets to a 2nd trust  
9           under sub. (2) is not an exercise of a general power of appointment.

10          (b) A trustee may appoint assets to a 2nd trust under sub. (2) even if the first  
11          trust includes a spendthrift clause or a provision that prohibits amendment or  
12          revocation of the trust.

13          (c) This section does not limit a trustee who has a power to invade principal to  
14          appoint property in further trust to the extent the power arises under the terms of  
15          the first trust or under any other section of this chapter or under another provision  
16          of law or under common law.

17          (d) The restriction relating to a trustee under sub. (3) (c) does not preclude a  
18          cotrustee who does not have a beneficial interest in the first trust from appointing  
19          assets to a 2nd trust under sub. (2) even if the terms of the first trust, applicable law,  
20          or other circumstances would otherwise require the majority or unanimous action of  
21          the trustees of the first trust.

22          (e) For purposes of this section, if beneficiaries of a first trust are defined as a  
23          class of persons, the class shall include any person who falls within the class of  
24          persons after the trustee appoints assets to the 2nd trust.

1 (f) Notwithstanding s. 701.0103 (23), a trustee of a first trust who appoints  
2 assets to a 2nd trust under sub. (2) or creates a 2nd trust instrument under sub. (4)  
3 is not the settlor of the 2nd trust.

4 (g) This section applies to a directing party or trust protector as if the directing  
5 party or trust protector is a trustee.

13 **SECTION 59.** 701.0501 of the statutes is created to read:

14 **701.0501 Rights of beneficiary's creditor or assignee.** (1) (a) To the  
15 extent a beneficiary's interest is not protected by a spendthrift provision, the court  
16 may authorize a judgment creditor or an assignee of the beneficiary to reach the  
17 beneficiary's interest by attachment of present or future distributions to or for the  
18 benefit of the beneficiary or other means. The court may limit the award to such  
19 relief as is appropriate under the circumstances.

20 (b) This subsection does not apply to a trust for an individual with a disability.

21 (2) A trustee is not liable to any creditor of a beneficiary for any distributions  
22 made to or for the benefit of the beneficiary if any of the following applies:

23 (a) The beneficiary's interest is protected by a spendthrift provision.



1 (b) The trust is a trust for an individual with a disability.

2 SECTION 60. 701.0502 of the statutes is created to read:

3 701.0502 Spendthrift provision. (1) A spendthrift provision is valid only  
4 if any of the following applies:

5 (a) The beneficiary is a person other than the settlor and is not treated as the  
6 settlor under s. 701.0505 (2).

7 (b) The trust is a trust for an individual with a disability.

8 (2) Subject to sub. (1), a term of a trust providing that the interest of a  
9 beneficiary is held subject to a spendthrift trust, or words of similar import, restrains  
10 both a voluntary and involuntary transfer of the beneficiary’s interest.

11 (3) A beneficiary may not transfer an interest in a trust in violation of a valid  
12 spendthrift provision and, except as otherwise provided in this subchapter, a creditor  
13 or assignee of the beneficiary may not attach, garnish, execute on, or otherwise reach  
14 the interest or a distribution by the trustee before its receipt by the beneficiary.

15 (4) Real property or tangible personal property that is owned by the trust but  
16 that is made available for a beneficiary’s occupancy or use in accordance with the  
17 trustee’s authority under the trust instrument may not be considered to have been  
18 distributed by the trustee or received by the beneficiary for purposes of allowing a  
19 creditor or assignee of the beneficiary to reach the property.

20 SECTION 61. 701.0503 (title) of the statutes is created to read:

21 701.0503 (title) Exceptions to spendthrift provision.

22 SECTION 62. 701.0504 of the statutes is created to read:

23 701.0504 Discretionary trusts; effect of standard. (1) For purposes of this  
24 subchapter, and except as provided in sub. (3), a beneficiary’s interest in a trust that  
25 is subject to the trustee’s discretion does not constitute an interest in property or an

1 enforceable right even if the discretion is expressed in the form of a standard of  
2 distribution or the beneficiary is then serving as sole trustee or cotrustee.

3 (2) Except as provided in this subchapter, a creditor or other claimant may not  
4 attach present or future distributions from a beneficiary's interest in property or an  
5 enforceable right, obtain an order from a court forcing the judicial sale of the interest  
6 or compelling the trustee to make distributions, or reach the interest or right by any  
7 other means, even if the trustee has abused the trustee's discretion.

8 (3) Subsections (1) and (2) do not apply if a beneficiary is acting as sole trustee  
9 of a trust for his or her benefit and his or her discretion to make distributions to  
10 himself or herself is not limited by an ascertainable standard or the consent of a party  
11 holding an adverse interest to the beneficiary.

12 (4) (a) Except as provided in par. (b), this section does not limit the right of a  
13 beneficiary to maintain a judicial proceeding against a trustee for an abuse of  
14 discretion or failure to comply with a standard for distribution.

15 (b) The right of a beneficiary described in par. (a) may not be exercised by a  
16 creditor.

17 **SECTION 63.** 701.0505 of the statutes is created to read:

18 **701.0505 Creditor's claim against settlor.** (1) (a) Whether or not the terms  
19 of a trust include a spendthrift provision and except as provided in par. (b), the  
20 following rules apply to claims of a settlor's creditors:

21 1. During the lifetime of the settlor, the property of a revocable trust is subject  
22 to claims of the settlor's creditors.

23 2. With respect to an irrevocable trust that is not a trust for an individual with  
24 a disability, upon application of a judgment creditor of the settlor, the court may, if  
25 the trust instrument requires or authorizes the trustee to make payments of income

1 or principal to or for the settlor, order the trustee to satisfy part or all of the judgment  
2 out of part or all of the payments of income or principal as they are due, presently  
3 or in the future, or which are payable in the trustee's discretion. If a trust has more  
4 than one settlor, the amount the judgment creditor of a particular settlor may reach  
5 may not exceed the settlor's interest in the trust.

6 3. After the death of a settlor, and subject to the settlor's right to direct the  
7 source from which liabilities will be paid, the property of a trust that was revocable  
8 at the settlor's death is subject to claims of the settlor's creditors, costs of  
9 administration of the settlor's estate, the expenses of the settlor's funeral and  
10 disposal of remains, and statutory allowances to a surviving spouse and children to  
11 the extent the settlor's probate estate is inadequate to satisfy those claims, costs,  
12 expenses, and allowances.

13 (b) Assets of a trust that are exempt from claims of creditors under other  
14 statutes are not subject to par. (a).

15 (2) For purposes of this subchapter, all of the following apply:

16 (a) During the period the power may be exercised, the holder of a power of  
17 withdrawal is treated in the same manner as the settlor of a revocable trust to the  
18 extent of the property subject to the power.

19 (e) 1. Contributions to the following trusts are not considered to have been  
20 contributed by the settlor:

21 a. An irrevocable living marital trust that is treated as qualified terminable  
22 interest property under section 2523 (f) of the Internal Revenue Code if after the  
23 death of the settlor's spouse the settlor is a beneficiary of the trust or an irrevocable  
24 trust that receives property from the trust.

1           b. An irrevocable living marital trust that is treated as a general power of  
2 appointment trust under section 2523 (e) of the Internal Revenue Code if after the  
3 death of the settlor's spouse the settlor is a beneficiary of the trust or an irrevocable  
4 trust that receives property from the trust.

5           c. An irrevocable living trust for the settlor's spouse if after the death of the  
6 settlor's spouse the settlor is a beneficiary of the trust or an irrevocable trust that  
7 receives property from the trust.

8           d. An irrevocable trust for the benefit of a person, the settlor of which is the  
9 person's spouse, regardless of whether or when the person was the settlor of an  
10 irrevocable trust for the benefit of that spouse.

11           e. An irrevocable trust for the benefit of a person to the extent that the property  
12 of the trust was subject to a general power of appointment in another person.

13           2. A person who would otherwise be treated as a settlor of a trust described in  
14 subd. 1. a. to e. is not treated as a settlor of the trust.

15           3. For purposes of this paragraph, notwithstanding s. 701.0103 (3),  
16 "beneficiary" means a person who satisfies s. 701.0103 (3) (a) or (b) and who is named  
17 in the initial trust instrument or through the exercise of a special or general power  
18 of appointment.

6 (d) A corporation or other person or enterprise in which the trustee, or a person  
7 that owns a significant interest in the trustee, has an interest that might affect the  
8 trustee's best judgment.

9 (4) A transaction not concerning trust property in which the trustee engages  
10 in the trustee's individual capacity involves a conflict between personal and fiduciary  
11 interests if the transaction concerns an opportunity properly belonging to the trust.

12 (5) An investment by a trustee in securities of an investment company or  
13 investment trust to which the trustee, or its affiliate, provides services in a capacity  
14 other than as trustee is not presumed to be affected by a conflict between personal  
15 and fiduciary interests if the investment otherwise complies with the prudent  
16 investor rule in s. 881.01. In addition to receiving compensation for acting as trustee,  
17 the trustee may be compensated by the investment company or investment trust for  
18 providing those services out of fees charged to the trust. If the trustee receives

18 or omitted with respect to the specified action except for acts or omissions that are  
19 a result of the trustee's willful misconduct.

20           (3) A trustee does not have a duty to do any of the following:

21           (a) Provide advice to, consult with, monitor, or evaluate a directing party's  
22 conduct.

23           (b) Inform or warn a beneficiary, a 3rd party, or a directing party that the  
24 trustee disagrees with any of the directing party's actions or directions.

25           (c) Prevent a directing party from giving a direction or taking any action.

1 (d) Compel a directing party to redress a breach of the directing party's duties.

2 (4) The administrative actions of a trustee related to matters within the scope  
3 of a directing party's power, including confirming that the directing party's directions  
4 have been carried out and recording and reporting actions taken pursuant to the  
5 directing party's direction, do not constitute either monitoring the directing party's  
6 actions or participating in the actions of the directing party.

7 (5) A directing party is a fiduciary and is required to act in good faith with  
8 regard to the terms of the trust and the interests of the beneficiaries. A directing  
9 party is liable for any loss that results from a breach of any of the directing party's  
10 fiduciary duties.

11 (6) (a) A directing party may request information about the trust from the  
12 trustee and, if the requested information is related to a power granted to the  
13 directing party, the trustee shall provide the requested information to the directing  
14 party. If a trustee is bound by any confidentiality restrictions with respect to  
15 information requested by a directing party, the trustee may require that the  
16 directing party agree to be bound by the confidentiality restrictions before delivering  
17 such information to the directing party. A trustee is not liable to any beneficiary for  
18 any loss or damages resulting from the trustee providing information to the directing  
19 party that is related to the power granted to the directing party.

20 (b) Except as otherwise provided in this chapter, a trustee does not have a duty  
21 to provide any information to the directing party that the directing party does not  
22 request.

23 (7) Sections 701.0701, 701.0708, 701.0709, 701.1001 to 701.1003, and 701.1005  
24 to 701.1010 apply to a directing party as if the directing party was a trustee.

1           (8) A person who accepts an appointment as a directing party of a trust submits  
2 to the jurisdiction of the courts of this state as provided in s. 701.0202 (1).

3           **SECTION 105.** 701.0809 of the statutes is created to read:

4           **701.0809 Control and protection of trust property.** A trustee shall take  
5 reasonable steps to take control of and protect the trust property.

6           **SECTION 106.** 701.0810 of the statutes is created to read:

7           **701.0810 Record keeping and identification of trust property.** (1) A  
8 trustee shall keep adequate records of the administration of the trust.

9           (2) A trustee shall keep trust property separate from the trustee's own  
10 property.

11           (3) Except as otherwise provided in sub. (4), a trustee shall cause the trust  
12 property to be designated so that the interest of the trust, to the extent feasible,  
13 appears in records maintained by a party other than a trustee or beneficiary.

14           (4) If the trustee maintains records clearly indicating the respective interests,  
15 a trustee may invest as a whole the property of 2 or more separate trusts.

16           **SECTION 107.** 701.0811 of the statutes is created to read:

17           **701.0811 Enforcement and defense of claims.** A trustee shall take  
18 reasonable steps to enforce claims of the trust known to the trustee and to defend  
19 claims against the trust known to the trustee.

20           **SECTION 108.** 701.0812 of the statutes is created to read:

21           **701.0812 Collecting trust property; duties of successor trustees.** (1) A  
22 trustee shall take reasonable steps to compel a former trustee or other person to  
23 deliver trust property to the trustee, and to redress a breach of trust known to the  
24 trustee to have been committed by a former trustee, a directing party, or a trust  
25 protector.

1           (2) A successor trustee does not have a duty to examine the accounts of a former  
2 trustee.

3           **SECTION 109.** 701.0813 of the statutes is created to read:

4           **701.0813 Duty to inform and report.** (1) A trustee shall keep the  
5 distributees or permissible distributees of trust income or principal, and other  
6 qualified beneficiaries who so request, reasonably informed about the  
7 administration of the trust. Unless unreasonable under the circumstances, a trustee  
8 shall promptly respond to a qualified beneficiary's request for information related to  
9 the administration of the trust.

10          (2) A trustee shall do all of the following:

11          (a) Upon the request of a qualified beneficiary for a copy of the trust  
12 instrument, promptly furnish to the qualified beneficiary either a copy of the  
13 portions of the trust instrument relating to the interest of the qualified beneficiary  
14 or a copy of the trust instrument.

15          (b) Within a reasonable period of time after accepting a trusteeship, notify the  
16 qualified beneficiaries of the acceptance and of the trustee's name, address, and  
17 telephone number.

18          (c) Within a reasonable period of time after the date on which the trustee  
19 acquires knowledge of the creation of an irrevocable trust, or the date on which the  
20 trustee acquires knowledge that a formerly revocable trust has become irrevocable,  
21 whether by the death of the settlor or otherwise, notify the qualified beneficiaries of  
22 all of the following:

- 23           1. The trust's existence.
- 24           2. The identity of the settlor or settlors.

1           3. The name, address, and telephone number of each directing party and trust  
2 protector.

3           4. The right to request a copy of the documentation referred to in par. (a).

4           5. The right to request information under sub. (1).

5           6. The right to a trustee's report as provided in sub. (3).

6           (d) Notify the distributees or permissible distributees of trust income or  
7 principal, and other qualified beneficiaries who so request, of any change in the  
8 method or rate of the trustee's compensation.

9           (e) Upon receiving a petition to the court for action under ss. 701.0411 to  
10 701.0416 that does not identify each trust protector and each directing party of the  
11 trust, notify the petitioning party of the identity of each trust protector and directing  
12 party, including the name, address, and telephone number of each trust protector  
13 and directing party, who is serving at the time the petition is filed.

14           **(3)** (a) At least annually and upon the termination of a trust, a trustee shall  
15 send to the distributees or permissible distributees of trust income or principal, and  
16 to other qualified beneficiaries who request it, all of the following:

17           1. A report of the trust property, liabilities, receipts, and disbursements,  
18 including the source and amount of the trustee's compensation.

19           2. A listing of the trust assets and, if feasible, their respective market values.

20           (b) Upon a vacancy in a trusteeship, unless a cotrustee remains in office, the  
21 former trustee shall send a report containing the information described under par.

22 (a) 1. to the qualified beneficiaries. A personal representative or guardian may send  
23 the qualified beneficiaries a report containing the information described in par. (a)

24 1. on behalf of a deceased or incapacitated trustee.

1           (4) A qualified beneficiary may waive the right to a trustee’s report or other  
2 information otherwise required to be furnished under this section. A qualified  
3 beneficiary, with respect to future reports and other information, may withdraw a  
4 waiver previously given.

5           (5) Subsections (2) (b) and (c) and (3) do not apply to a trustee who accepts a  
6 trusteeship before the effective date of this subsection .... [LRB inserts date], to an  
7 irrevocable trust created before the effective date of this subsection .... [LRB inserts  
8 date], or to a revocable trust that becomes irrevocable before the effective date of this  
9 subsection .... [LRB inserts date].

10           **SECTION 110.** 701.0814 of the statutes is created to read:

11           **701.0814 Discretionary powers; tax savings.** (1) Notwithstanding the  
12 breadth of discretion granted to a trustee in the terms of the trust, including the use  
13 of such terms as “absolute,” “sole,” or “uncontrolled,” the trustee shall exercise a  
14 discretionary power in good faith and in accordance with the terms and purposes of  
15 the trust and the interests of the beneficiaries. A court may not determine that a  
16 trustee abused its discretion merely because the court would have exercised the  
17 discretion in a different manner or would not have exercised the discretion.

18           (2) Subject to sub. (4), and unless the terms of the trust expressly indicate that  
19 a provision of this subsection does not apply, all of the following apply:

20           (a) A person other than a settlor who is a beneficiary and a trustee, directing  
21 party, or trust protector of a trust that confers on the trustee, directing party, or trust  
22 protector a power to make discretionary distributions to or for the trustee’s, directing  
23 party’s, or trust protector’s personal benefit may exercise the power only in  
24 accordance with an ascertainable standard.

1 (b) A trustee, directing party, or trust protector may not exercise a power to  
2 make discretionary distributions to satisfy a legal obligation of support that the  
3 trustee, directing party, or trust protector personally owes another person.

4 (3) A power whose exercise is limited or prohibited by sub. (2) may be exercised  
5 by a majority of the remaining trustees, directing parties, or trust protectors whose  
6 exercise of the power is not so limited or prohibited. If the power of all trustees,  
7 directing parties, or trust protectors is so limited or prohibited, the court may appoint  
8 a trustee, directing party, or trust protector with authority to exercise the power.

9 (4) Subsection (2) does not apply to any of the following:

10 (a) A power held by the settlor's spouse who is the trustee, directing party, or  
11 trust protector of a trust for which a marital deduction, as defined in section 2056 (b)  
12 (5) or 2523 (e) of the Internal Revenue Code, was previously allowed.

13 (b) A trust during a period when the trust may be revoked or amended by its  
14 settlor.

15 (c) A trust if contributions to the trust qualify for the annual exclusion under  
16 section 2503 (c) of the Internal Revenue Code.

17 **SECTION 111.** 701.0815 of the statutes is created to read:

18 **701.0815 General powers of trustee.** (1) A trustee, without authorization  
19 by the court, may exercise the following powers:

20 (a) Powers conferred by the terms of the trust.

21 (b) Except as limited by the terms of the trust, all of the following powers:

22 1. All powers over the trust property that an unmarried, competent owner has  
23 over individually owned property.

24 2. Any other powers appropriate to achieve the proper investment,  
25 management, and distribution of the trust property.



1           3. Any other powers conferred by this chapter.

2           (2) The exercise of a power is subject to the fiduciary duties prescribed by this  
3 chapter.

4           **SECTION 112.** 701.0816 of the statutes is created to read:

5           **701.0816 Specific powers of trustee.** Without limiting the authority  
6 conferred by s. 701.0815, a trustee may do all of the following:

7           (1) Collect trust property and accept or reject additions to the trust property  
8 from a settlor or any other person.

9           (2) Acquire or sell property, for cash or on credit, at public or private sale.

10          (3) Exchange, partition, or otherwise change the character of trust property.

11          (4) Deposit trust money in an account in a regulated financial-service  
12 institution.

13          (5) Borrow money, with or without security, and mortgage or pledge trust  
14 property for a period within or extending beyond the duration of the trust.

15          (6) With respect to an interest in a proprietorship, partnership, limited liability  
16 company, business trust, corporation, or other form of business or enterprise,  
17 continue the business or other enterprise and take any action that may be taken by  
18 shareholders, members, or property owners, including merging, dissolving, or  
19 otherwise changing the form of business organization or contributing additional  
20 capital.

21          (7) With respect to a stock or other security, exercise the rights of an absolute  
22 owner, including the right to do any of the following:

23           (a) Vote, or give proxies to vote, with or without power of substitution, or enter  
24 into or continue a voting trust agreement.

1           (b) Hold a stock or other security in the name of a nominee or in other form  
2 without disclosure of the trust so that title may pass by delivery.

3           (c) Pay calls, assessments, and other sums chargeable or accruing against the  
4 stock or other security, and sell or exercise stock subscription or conversion rights.

5           (d) Deposit the stock or other security with a depository or other regulated  
6 financial–service institution.

7           (8) With respect to an interest in real property, construct, or make ordinary or  
8 extraordinary repairs to, alterations to, or improvements in, buildings or other  
9 structures, demolish improvements, raze existing or erect new party walls or  
10 buildings, subdivide or develop land, dedicate land to public use or grant public or  
11 private easements, and make or vacate plats and adjust boundaries.

12           (9) Enter into a lease for any purpose as lessor or lessee, including a lease or  
13 other arrangement for exploration and removal of natural resources, with or without  
14 the option to purchase or renew, for a period within or extending beyond the duration  
15 of the trust.

16           (10) Grant an option involving a sale, lease, or other disposition of trust  
17 property or acquire an option for the acquisition of property, including an option  
18 exercisable beyond the duration of the trust, and exercise an option so acquired.

19           (11) Insure the property of the trust against damage or loss and insure the  
20 trustee, the trustee’s agents, any directing party, any trust protector, and the  
21 beneficiaries against liability arising from the administration of the trust.

22           (12) Abandon or decline to administer property of no value or of insufficient  
23 value to justify its collection or continued administration.

24           (13) With respect to possible liability for violation of environmental law, do any  
25 of the following:

1           (a) Inspect or investigate property the trustee holds or has been asked to hold,  
2           or property owned or operated by an organization in which the trustee holds or has  
3           been asked to hold an interest, for the purpose of determining the application of  
4           environmental law with respect to the property.

5           (b) Take action to prevent, abate, or otherwise remedy any actual or potential  
6           violation of any environmental law affecting property held directly or indirectly by  
7           the trustee, whether taken before or after the assertion of a claim or the initiation  
8           of governmental enforcement.

9           (c) Decline to accept property into trust or disclaim any power with respect to  
10          property that is or may be burdened with liability for violation of environmental law.

11          (d) Compromise claims against the trust that may be asserted for an alleged  
12          violation of environmental law.

13          (e) Pay the expense of any inspection, review, abatement, or remedial action to  
14          comply with environmental law.

15          (14) Pay or contest any claim, settle a claim by or against the trust, and release,  
16          in whole or in part, a claim belonging to the trust.

17          (15) Pay taxes; assessments; compensation of the trustee, a directing party, a  
18          trust protector, and employees and agents of the trust; and other expenses incurred  
19          in the administration of the trust.

20          (16) Exercise elections with respect to federal, state, and local taxes.

21          (17) Select a mode of payment under any employee benefit or retirement plan,  
22          annuity, or life insurance payable to the trustee, exercise rights thereunder,  
23          including exercise of the right to indemnification for expenses and against liabilities,  
24          and take appropriate action to collect the proceeds.

1           **(18)** Make loans out of trust property, including loans to a beneficiary on terms  
2 and conditions the trustee considers to be fair and reasonable under the  
3 circumstances. The trustee has a lien on future distributions for repayment of loans  
4 under this subsection.

5           **(19)** Pledge trust property to guarantee loans made by others to the beneficiary.

6           **(20)** Appoint a trustee to act in another jurisdiction with respect to trust  
7 property located in the other jurisdiction, confer upon the appointed trustee all of the  
8 powers and duties of the appointing trustee, require that the appointed trustee  
9 furnish security, and remove any trustee so appointed.

10          **(21)** Pay an amount distributable to a beneficiary who is under a legal  
11 disability or who the trustee reasonably believes is incapacitated, by paying it  
12 directly to the beneficiary, applying it for the beneficiary's benefit, or by doing any  
13 of the following:

14           (a) Paying the amount to the beneficiary's conservator or the beneficiary's  
15 guardian of the estate.

16           (b) Paying the amount to the beneficiary's custodian under the Uniform  
17 Transfers to Minors Act under ss. 54.854 to 54.898 or the Uniform Custodial Trust  
18 Act under ss. 54.950 to 54.988, and, for that purpose, creating a custodianship or  
19 custodial trust.

20           (c) If the trustee does not know of a conservator, guardian of the estate,  
21 custodian, or custodial trustee, paying the amount to an adult relative or other  
22 person having legal or physical care or custody of the beneficiary or to the guardian  
23 of the person of the beneficiary, to be expended on the beneficiary's behalf.

24           (d) Managing the amount as a separate fund on the beneficiary's behalf, subject  
25 to the beneficiary's continuing right to withdraw the distribution.

1           (22) On distribution of trust property or the division or termination of a trust,  
2           make distributions in divided or undivided interests, allocate particular assets in  
3           proportionate or disproportionate shares, value the trust property for those  
4           purposes, and adjust for resulting differences in valuation.

5           (23) Resolve a dispute concerning the interpretation of the trust or its  
6           administration by mediation, arbitration, or other procedure for alternative dispute  
7           resolution.

8           (24) Prosecute or defend an action, claim, or judicial proceeding in any  
9           jurisdiction to protect trust property or the trustee, a directing party, or a trust  
10          protector in the performance of the trustee's, directing party's or trust protector's  
11          duties.

12          (25) Sign and deliver contracts and other instruments that are useful to  
13          achieve or facilitate the exercise of the trustee's, directing party's or trust protector's  
14          powers.

15          (26) On termination of the trust, exercise the powers appropriate to wind up  
16          the administration of the trust and distribute the trust property to the persons  
17          entitled to it.

18          (27) Create or fund a plan under section 529 of the Internal Revenue Code, or  
19          other college savings vehicle, for a beneficiary's benefit.

20          **SECTION 113.** 701.0817 of the statutes is created to read:

21          **701.0817 Distribution upon termination.** (1) Upon termination or partial  
22          termination of a trust, the trustee may send a proposal for distribution to the  
23          beneficiaries of the trust. The right of any beneficiary to whom the proposal is sent  
24          to object to the proposed distribution terminates if the beneficiary does not notify the  
25          trustee of an objection within 30 days after the proposal was sent but only if the

1 proposal informed the beneficiary of the right to object and of the time allowed for  
2 objection.

3 (2) Upon the occurrence of an event terminating or partially terminating a  
4 trust, the trustee shall proceed within a reasonable time to distribute the trust  
5 property to the persons entitled to it, subject to the right of the trustee to retain a  
6 reasonable reserve for the payment of debts, expenses, and taxes.

7 (3) A release by a beneficiary of a trustee from liability for breach of trust is  
8 invalid to the extent any of the following applies:

9 (a) The release was induced by improper conduct of the trustee.

10 (b) The beneficiary, at the time of the release, did not know of the beneficiary's  
11 rights or of the material facts relating to the breach.

12 **SECTION 114.** 701.0818 of the statutes is created to read:

13 **701.0818 Trust protectors.** (1) **APPOINTMENT.** A settlor, in a trust  
14 instrument, or a court, in a trust instrument or court order, may provide for the  
15 appointment of a trust protector, whether referred to as a trust protector, another  
16 title, or no title. A trust protector has the powers granted to the trust protector in  
17 the trust instrument.

18 (2) **TRUST PROTECTOR POWERS; LEGAL CAPACITY.** (a) A settlor, in a trust  
19 instrument, or a court, in a trust instrument or court order, may specify that a  
20 particular power granted to a trust protector is exercisable in a fiduciary or  
21 nonfiduciary capacity and whether a power granted to the trust protector in a  
22 nonfiduciary capacity is required to be exercised in good faith.

23 (b) If a settlor or the court does not specify in a trust instrument that a  
24 particular power granted to a trust protector is exercisable in a fiduciary or  
25 nonfiduciary capacity, all of the following apply:

1           1. The trust protector shall exercise the power in a fiduciary capacity if it is a  
2 power to do any of the following:

- 3           a. Interpret or enforce the terms of the trust at the request of the trustee.  
4           b. Review and approve the trustee's reports or accounting.  
5           c. Resolve disputes between the trustee or a directing party and a beneficiary.  
6           d. Consent to or veto distributions to a beneficiary.  
7           e. Consent to or veto investment actions.

8           2. If it is not a power described in subd. 1. a. to e., the trust protector shall  
9 exercise the power in a nonfiduciary capacity including a power to do any of the  
10 following:

11           a. Modify or amend the trust instrument to respond to opportunities related  
12 to, or changes in, restraints on alienation or other state laws restricting the terms  
13 of a trust, the distribution of trust property, or the administration of the trust.

14           b. Modify or amend the trust instrument to achieve a different tax status or to  
15 respond to changes in federal or state law.

16           c. Change the principal place of administration, the tax situs of the trust, or the  
17 governing law of the trust.

18           d. Eliminate or modify the interests of a beneficiary, add a new beneficiary or  
19 class of beneficiaries, or select a beneficiary from an indefinite class.

20           e. Modify the terms of a power of appointment granted under the trust.

21           f. Remove, replace, or appoint a trustee, trust protector, or directing party or  
22 a successor trustee, trust protector, or directing party.

23           g. Terminate the trust.

24           h. Appoint assets to a new trust under s. 701.0418.

1 i. Advise the trustee on matters concerning a beneficiary, including whether to  
2 provide information to a beneficiary under s. 701.0813.

3 j. Correct errors or ambiguities in the terms of the trust that might otherwise  
4 require court construction or defeat the settlor's intent.

5 3. Notwithstanding subs. 1. and 2., a trust protector who is also the settlor  
6 may exercise any power granted to the trust protector in the trust protector's  
7 personal interests.

8 4. Notwithstanding subd. 2., a trust protector who is also a qualified beneficiary  
9 may exercise any power granted to the trust protector that is exercisable in a  
10 nonfiduciary capacity in the trust protector's personal interests.

11 (c) Notwithstanding pars. (a) and (b) and any provision in the trust instrument  
12 to the contrary, a trust protector who is also serving as the trustee or a directing party  
13 shall exercise any power granted to the trust protector in a fiduciary capacity.

14 **(3) TRUST PROTECTOR POWERS; DUTIES.** (a) If a power is exercisable in a fiduciary  
15 capacity, the trust protector shall act in good faith and shall exercise the power in a  
16 manner that is consistent with the terms and purposes of the trust instrument or  
17 court order and the interests of the beneficiaries.

18 (b) If a power is exercisable in a nonfiduciary capacity, the trust protector shall  
19 act in good faith unless the trust instrument or court order provides otherwise.

20 (c) A trust protector does not have a duty to exercise its powers, to monitor the  
21 conduct of the trustee or any directing party, or to monitor changes in the law or  
22 circumstances of the beneficiaries.

23 **(4) LIABILITY.** A trust protector is liable for any loss that results from a breach  
24 of the trust protector's duties, except as follows:



1 (a) If the trust protector is also the settlor, the trust protector is not liable for  
2 any loss that results from a breach of the trust protector's duties.

3 (b) If the trust protector is also a qualified beneficiary, the trust protector is not  
4 liable for any loss that results from a breach of the trust protector's duties for a power  
5 that is exercised in a nonfiduciary capacity.

6 (5) RESIGNATION AND RELEASE OF POWERS. A trust protector may resign or  
7 release a power granted to the trust protector by giving written notice to the trustee  
8 and to any successor trust protector.

9 (6) PROHIBITED ACTIONS. A trust protector may not exercise a power granted to  
10 the trust protector to do any of the following:

11 (a) Except as provided in sub. (2) (b) 3. and 4., create or expand any beneficial  
12 interest, power of appointment, right of withdrawal, or right to receive trust property  
13 as a result of the exercise of a power of appointment if the creation or expansion  
14 would benefit the trust protector, the trust protector's estate, the trust protector's  
15 creditors, or creditors of the trust protector's estate.

16 (b) Modify or amend a trust to do any of the following:

17 1. Remove a requirement pursuant to 42 USC 1396p (d) (4) to pay back a  
18 governmental entity for benefits provided to the permissible beneficiary at the death  
19 of that beneficiary.

20 2. Reduce or eliminate an income interest of an income beneficiary of any of the  
21 following trusts:

22 a. A trust for which a marital deduction has been taken for federal income tax  
23 purposes under section 2056 or 2523 of the Internal Revenue Code or for state tax  
24 purposes under any comparable provision of applicable state law, during the life of  
25 the settlor's spouse.

1           b. A charitable remainder trust under section 664 of the Internal Revenue  
2 Code, during the life of the noncharitable beneficiary.

3           c. A grantor retained annuity trust under section 2702 of the Internal Revenue  
4 Code, during any period in which the settlor is a beneficiary.

5           d. A trust for which an election as a qualified Subchapter S Trust under section  
6 1361(d) of the Internal Revenue Code is in place.

7           (c) Modify any beneficial interest of a trust that qualified for a marital  
8 deduction or charitable deduction from federal or state estate tax in a manner that  
9 would have caused the trust not to qualify for the deduction.

10           **(7) SETTLOR RIGHTS.** A trust protector is not subject to the direction of the settlor  
11 and the settlor may not bring a cause of action against the trust protector. A trust  
12 protector may consider a settlor's goals, objectives, and philosophies in establishing  
13 the trust and the trust's structure when exercising the powers granted to the trust  
14 protector and may do so regardless of whether the settlor is deceased.

15           **(8) DUTIES OF A TRUSTEE AND A DIRECTING PARTY.** (a) A trustee and a directing  
16 party shall act in accordance with a trust protector's exercise of a power granted to  
17 the trust protector. A trustee and a directing party are not liable for acting in  
18 accordance with the trust protector's exercise of a power granted to the trust  
19 protector unless the attempted exercise is manifestly contrary to the power granted  
20 to the trust protector or the trustee or the directing party knows that the attempted  
21 exercise would constitute a breach of a duty that the trust protector owes to the  
22 beneficiaries of the trust.

23           (b) A trustee and a directing party do not have a duty to monitor the conduct  
24 of the trust protector, provide advice to or consult with the trust protector, or  
25 communicate with, warn, or apprise any beneficiary concerning instances in which

1 the trustee or the directing party would or might have exercised the trustee's or the  
2 directing party's discretion in a manner different from the manner in which the trust  
3 protector exercised its discretion.

4 (9) RIGHT TO INFORMATION. (a) A trust protector may request information about  
5 the trust from the trustee and, if the requested information is related to a power  
6 granted to the trust protector, the trustee shall provide the requested information to  
7 the trust protector. If a trustee is bound by any confidentiality restrictions with  
8 respect to information requested by a trust protector, the trustee may require that  
9 the trust protector agree to be bound by the confidentiality restrictions before  
10 delivering such information to the trust protector. A trustee is not liable to any  
11 beneficiary for any loss or damages resulting from the trustee providing information  
12 to the trust protector that is related to the power granted to the trust protector.

13 (b) Except as otherwise provided in this chapter, a trustee does not have to  
14 provide any information to the trust protector that the trust protector does not  
15 request.

16 (10) PAYMENT OR REIMBURSEMENT OF ATTORNEY FEES AND COSTS. A trustee shall,  
17 in accordance with s. 701.1004, pay or reimburse a trust protector for attorney fees  
18 and costs to defend any claim made against the trust protector.

19 (11) APPLICATION OF OTHER SECTIONS TO TRUST PROTECTORS. Sections 701.0701,  
20 701.0708, 701.0709, 701.1001 to 701.1003, and 701.1005 to 701.1010 apply to a trust  
21 protector as if the trust protector is the trustee.

22 (12) JURISDICTION. A person who accepts an appointment as a trust protector  
23 of a trust submits to the jurisdiction of the courts of this state, as provided in s.  
24 701.0202 (1).
