ASSEMBLY AMENDMENT 3,
TO ASSEMBLY BILL 27

April 2, 2013 - Offered by Representatives GOYKE, WACHS and HEBL.

1 At the locations indicated, amend the bill as follows:

2 1. Page 1, line 3: after "basis" insert "and for legal services that expend more
3 than ~~\$10,000~~". *\$25,000*

4 2. Page 2, line 5: after "20.9305." insert "If the estimated expenditure for the
5 compensation is ~~\$10,000~~ or more, the contract is subject to s. 20.9306.". *\$25,000*

6 3. Page 2, line 14: after "20.9305." insert "If the estimated expenditure for the
7 compensation is ~~\$10,000~~ or more, the contract is subject to s. 20.9306.". *\$25,000*

8 4. Page 6, line 7: after that line insert:
9 "SECTION 3d. 20.9306 of the statutes is created to read:

10 **20.9306 Contracting for legal services; expenditures for ~~\$10,000~~ or**
11 **more.** Unless s. 20.9305 applies to the contract, if a state contracts for legal services
12 and the estimated expenditure is ~~\$10,000~~ or more in the current biennium, the

1 governor shall ensure that all of the following are available to the public on the
2 Internet site of the office of the governor:

3 (1) A copy of the contract entered into for the legal services during the period
4 beginning 5 days after the contract is entered into and ending when the contract and
5 all of its extensions expire or are terminated.

6 (2) A copy of the governor's written determination stating that contracting for
7 legal services is cost-effective and in the public interest and including all of the
8 following:

9 (a) A finding that the attorney general's office lacks sufficient and appropriate
10 legal and financial resources, which necessitates the need to contract for the legal
11 services.

12 (b) The amount of time and labor required to perform the legal services,
13 including the novelty, complexity, and difficulty of the legal issues involved and the
14 required skill.

15 (c) The geographic area where the legal services are to be provided.

16 (d) The amount of experience with similar legal issues or cases needed for the
17 particular type of legal services to be provided.

18 (3) Notice of the amount of any amount paid under a contract entered into
19 under this section during the period beginning 15 days after payment is made and
20 ending 365 days after the payment is made." ✓

21 5. Page 6, line 18: after "20.9305." insert "If the estimated expenditure for the
22 compensation is \$10,000 or more, the contract is subject to s. 20.9306." ✓
