

1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 15: before that line insert:

3 "SECTION 2m. 16.413 (3) (am) of the statutes is created to read:

4 16.413 (3) (am) The department shall ensure that all of the information under  
5 par. (a) 1. to 5. relating to each contract for legal services on a contingent fee basis  
6 entered into under s. 20.9305 is immediately and completely available for inspection  
7 on a searchable Internet Web site maintained by the department.

8 SECTION 2p. 16.413 (3) (b) of the statutes is amended to read:

9 16.413 (3) (b) State agencies shall provide the department with all of the  
10 information required under par. (a). The governor shall provide the department with  
11 all of the information required under par. (am). The department may specify the

1 format in which ~~state agencies provide~~ the information is provided. The department  
2 shall make the information available on the searchable Internet Web site.”.
