Transitional Jobs Proposal for Fall 2013 Legislative Session



Scope - Transitional Jobs Demonstration Project (TJDP)

The Transitional Jobs Demonstration Project (TJDP) was a subsidized training and employment program targeted to low-income adults. The program was designed to improve the employability of individuals with significant barriers to employment such as a weak work record, low educational level, minimal job skills, or a history with the criminal justice system.

Background

The Department of Children and Families (DCF) administered the TJDP between September 2010 and June 2013. Authorized in the Wisconsin Biennial Budget Act of 2009-2011, Wisconsin Act 28, the \$28 million project was supported through the Temporary Assistance for Needy Families (TANF) Emergency Funds (EF) available through the American Recovery and Reinvestment Act (ARRA) of 2009, as well as other TANF funding.

The \$28 million includes the additional \$3 million from May 2012. Governor Walker's Administration supported and the Department of Administration approved the DCF's request to reallocate within the TANF/Child Care budget for SFY12 an additional \$3,000,000 to the TJDP from under spending in the direct child care services and the safety and out-of-home placement services allocations. These funds were contracted to UMOS, Inc. to increase funding for transitional job services in Milwaukee County. Total funding available for the TJDP was \$28,151,500.

Experience

DCF administered the TJDP in 38 counties through partnerships with 17 contracting agencies located in Milwaukee County and the balance of state. These contracting agencies included Wisconsin Works (W-2) agencies, Community Action Programs, Workforce Investment Boards, and other private community-based agencies. The contracting agencies were responsible for developing partnerships with businesses and organizations to host the transitional job positions. DCF encouraged contractors to work with businesses or host sites that could successfully maintain an expansion of their workforce after the end of the subsidized period. Over 800 businesses and organizations participated as host sites. Many businesses participating in TJDP indicated the program allowed them to expand their workforces during a time when they were unable to access traditional credit markets due to the 2008 financial crisis and subsequent recession. These host sites included for-profit, non-profit, and governmental organizations. A total of 4,074 workers participated in the program from September 2010 through June 2013.

Evaluation

The department's evaluation of TJDP showed that a majority of workers in the program obtained unsubsidized employment both initially and during a two-quarter follow-up period. The longer a worker stayed in the program, the more likely he/she was to obtain unsubsidized employment. Compared to two quarters before entering the TJDP, average earnings of TJDP workers increased in the two quarters after leaving the TJDP. A TJ worker who had a recent employment history (i.e. earned wages) two quarters prior to entering the TJDP was more likely to get an unsubsidized job and subsequently slightly higher wages than a worker with no recent employment history prior to entering the TJDP. While the amount of court ordered child support remained constant, workers who participated in the TJDP more than doubled

the amount of child support they were paying prior to entering the program. Felons and non-felons had

different outcomes when participating in the TJDP. Felons were less likely to obtain unsubsidized employment than non-felons; however, if they did obtain unsubsidized employment, their earnings and child support payments increased similarly to non-felons.

Governor Walker's Transform Milwaukee Jobs Proposal

Building on the success of the TJDP, the Governor included a successor program, the Transform Milwaukee Jobs Program (TMJP) in his 2013-2015 budget. That program was authorized by the Legislature in 2013 Wis. Act 20. DCF is currently developing a Request for Proposal to select one or more contractors to administer the TMJP. The biennial appropriation for TMJP is \$8.75 million, and the program will be targeted to approximately 1100 unemployed workers who reside within the Transform Milwaukee Initiative redevelopment area in the City of Milwaukee.

Description of Future Expansion of Transitional Jobs Proposal

The current TMJP does not address the employment needs of communities outside Milwaukee County, some of which have unemployment and poverty rates equal to or higher than Milwaukee's. To address the needs of these communities outside Milwaukee, DCF is proposing a Transitional Jobs Program (TJP) to serve cities or counties with relatively high unemployment and/or child poverty rates. DCF proposes to administer TJP on exactly the same terms as the TMJP in Milwaukee, with one exception – the program will serve unemployed workers outside Milwaukee in areas selected by DCF based on community unemployment and child poverty rates. The number of areas that can be served will depend on funding.

DCF is suggesting the following language to implement the proposal. Since the programs have the same eligibility requirements and scope, it may be possible to combine them into one section of the Statutes, however that choice can be left to the drafters. The intent here is simply to describe the TJP as conforming to the provisions currently in statute authorizing the Transform Milwaukee Jobs Program.

49.1633 Transitional Jobs program. (1) The department shall establish a program that offers transitional jobs to low-income adults outside Milwaukee County. The program shall conform in all respects, except location, to the provisions of s. 49.163(1)-(6).

(2) To the extent of available funds, the department shall conduct the program in at least one geographic area that are not in Milwaukee County, and in selecting the geographic areas, shall consider those areas with relatively high rates of unemployment and childhood poverty.

General Talking Points

Program Goals

The Transitional Jobs program was established to provide *low income adults* with an immediate income, an opportunity to develop the skills and experience their local labor market demands, and a positive work history. It provides to those without other options with longer-term career preparation and support to move to unsubsidized employment.

Additionally the program provides *businesses* with needed workers at no risk or expense to the business. Transitional workers add the most value to businesses that want to either stay open or expand, but cannot immediately hire and pay new employees due to reduced revenue or reduced access to short-term credit lines. By completing projects and sustaining operations when cash is tight, transitional workers help position businesses to hire more permanent employees.

Transitional Jobs Workers

Individuals in the Transitional Jobs Demonstration Project are people who are both unemployed and truly have no other program options. These projects target individuals who do not qualify for unemployment insurance or Wisconsin Works (W-2). Many agencies are targeting non-custodial parents and FoodShare Employment and Training participants for the available transitional jobs.

Transitional Jobs Strengthen Families by:

- Helping unemployed parents work thereby increasing their earnings and household income
- Applying earnings towards child support, reducing the debts of non-custodial parents', helping custodial parents better provide for their children and improve their relationships
- Putting parents to work who are unemployed, not receiving UI, and not receiving W-2
- Giving both parents the opportunity to work, which supports the formation of two parent families
- Making a real work opportunity available to unemployed non-custodial parents
- Providing Transitional Jobs workers with the Earned Income Tax Credit

Transitional Jobs Support the Economy by:

- Targeting employers who have a specific demand for workers
- Subsidizing wages and easing the tension on employers' labor budgets, which will allow them to increase labor capacity
- Not just supplying employers with workers, but also providing the workers with the basic skills to get the work done
- Putting unemployed people to work, which will reduce expenses incurred by other government services

Analysis by the Legislative Reference Bureau

Current law requires the Department of Children and Families (DCF) to establish a Transform Milwaukee Jobs program (TMJ program) in Milwaukee County under which DCF pays to an employer, or a person with which DCF contracts to administer the program (contractor), that employs a program participant a wage subsidy that is equal to the wage the employer or contractor pays the participant, up to 40 hours per week at minimum wage. The employer or contractor must employ the participant at least 20 hours per week at a location in this state and pay at least minimum wage, although the employer, or contractor with the approval of DCF, may pay the participant more than the wage subsidy. An individual may participate in the program for a maximum of 1,040 hours, which is equivalent to 26 40-hour weeks. In addition to paying the wage subsidy, DCF may reimburse an employer or contractor for certain taxes, unemployment (contributions or taxes, and worker's compensation insurance premiums that are attributable to employment of the zinsurance participant.

To be eligible to participate in the TMJ program, an individual must be at least 18 years old, and, if over 24 years old, must be the parent or primary relative caregiver of a child under the age of 18. The individual must have household income below 150 percent of the poverty line, be unemployed for at least four weeks, be ineligible to receive unemployment benefits, and not be participating in a Wisconsin Works (W-2) employment position. A program participant may be eligible for a child care subsidy under Wisconsin Shares, which generally provides child care subsidies for participants in W-2, if the program participant needs child care services in order

to participate in the program.

DCF may administer the TMJ program or contract with any person, including a W-2 agency, county department, local workforce development board, or community action agency, to perform administrative functions, including determining eligibility, providing or identifying employers to provide jobs for eligible individuals, providing job orientation and employment services, and maintaining participant demographic, eligibility, and employment records. DCF may recover an overpayment from a participant that results from a misrepresentation about his or her eligibility, and must recover an overpayment from a contractor that results from a failure to comply with the contract or to meet performance standards established by DCF.

This bill requires DCF to establish a Transitional Jobs program, with the same provisions as the TMJ program, in one or, to the extent of available funds, more geographic areas of the state that are not in Milwaukee County. In selecting the geographic area or areas in which to conduct the Transitional Jobs program, DCF must give priority to those areas with relatively high rates of unemployment and childhood poverty.

Analysis by the Legislative Reference Bureau

Current law requires the Department of Children and Families (DCF) to establish a Transform Milwaukee Jobs program (TMJ program) in Milwaukee County under which DCF pays to an employer, or a person with which DCF contracts to administer the program (contractor), that employs a program participant a wage subsidy that is equal to the wage the employer or contractor pays the participant, up to 40 hours per week at minimum wage. The employer or contractor must employ the participant at least 20 hours per week at a location in this state and pay at least minimum wage, although the employer, or contractor with the approval of DCF, may pay the participant more than the wage subsidy. An individual may participate in the program for a maximum of 1,040 hours, which is equivalent to 26 40—hour weeks. In addition to paying the wage subsidy, DCF may reimburse an employer or contractor for certain taxes, unemployment insurance contributions or taxes, and worker's compensation insurance premiums that are attributable to employment of the participant.

To be eligible to participate in the TMJ program, an individual must be at least 18 years old, and, if over 24 years old, must be the parent or primary relative caregiver of a child under the age of 18. The individual must have household income

below 150 percent of the poverty line, be unemployed for at least four weeks, be ineligible to receive unemployment insurance benefits, and not be participating in a Wisconsin Works (W-2) employment position. A program participant may be eligible for a child care subsidy under Wisconsin Shares, which generally provides child care subsidies for participants in W-2, if the program participant needs child care services in order to participate in the program.

DCF may administer the TMJ program or contract with any person, including a W-2 agency, county department, local workforce development board, or community action agency, to perform administrative functions, including determining eligibility, providing or identifying employers to provide jobs for eligible individuals, providing job orientation and employment services, and maintaining participant demographic, eligibility, and employment records. DCF may recover an overpayment from a participant that results from a misrepresentation about his or her eligibility, and must recover an overpayment from a contractor that results from a failure to comply with the contract or to meet performance standards established by DCF.

This bill authorizes DCF to establish a Transitional Jobs program if funding is available, with the same provisions as the TMJ program, in one or more geographic areas of the state that are not in Milwaukee County, to the extent of available funds. In selecting the geographic area or areas in which to conduct the Transitional Jobs program, DCF must give priority to those areas with relatively high rates of unemployment and childhood poverty.
