49.163 (7) Funding for the Transitional Jobs program. Before implementing the Transitional Jobs program, the department shall submit to the joint committee on finance a request for the release of funds for the program. If the joint committee on finance approves the request, the joint committee on finance shall release to the department from the appropriation under s. 20.865 (4) (a) up to \$440,000 in each fiscal year of the 2019–15 fiscal biennium to supplement one or more general purpose revenue sum certain appropriations of the department for the program. 
