8 on finance a request for the release of funds for the program. If the joint committee

9 on finance approves the request, the joint committee on finance shall release to the

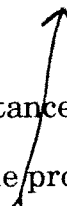

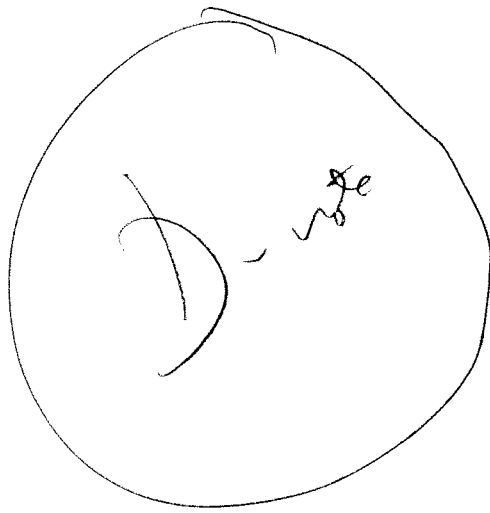
