- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 3, line 7: delete "available" and substitute "released under sub. (7)".
- 3 **2.** Page 3, line 8: delete "available" and substitute "the released".
- 4 **3.** Page 4, line 6: after that line insert:
- 5 "**SECTION 8m.** 49.163 (7) of the statutes is created to read:
- 6 49.163 (7) FUNDING FOR THE TRANSITIONAL JOBS PROGRAM. Before implementing
- 7 the Transitional Jobs program, the department shall submit to the joint committee
- 8 on finance a request for the release of funds for the program. If the joint committee
- 9 on finance approves the request, the joint committee on finance shall release to the
- 10 department from the appropriation under s. 20.865 (4) (a) up to \$440,000 in each
- 11 fiscal year of the 2013-15 fiscal biennium to supplement one or more general purpose
- 12 revenue sum certain appropriations of the department for the Transitional Jobs
- 13 program. The department may not use any federal Temporary Assistance for Needy

1 Families block grant funds received under 42 USC 601 et seq. for the Transitional  
2 Jobs program.”.

3 4. Page 4, line 10: delete “and the” and substitute “and, subject to s. 49.163 (7),  
4 the”.
