

3 "SECTION 16m. 101.983 (3) of the statutes, as created by 2013 Wisconsin Act  
4 20, is amended to read:

5 101.983 (3) INSPECTIONS; INDIVIDUAL RESIDENTIAL DWELLING UNITS. ~~No owner of~~  
6 ~~a residence may sell or otherwise transfer~~ If the owner and a prospective buyer of an  
7 individual residential dwelling unit that is served by a dumbwaiter or an elevator  
8 unless the owner provides the purchaser or transferee, prior to the sale or transfer  
9 of the property, with an inspection report from enter into a contract of sale for the unit  
10 that includes a provision requiring that the dumbwaiter or elevator be inspected, the  
11 inspection shall be performed by an elevator inspector licensed under s. 101.985 (3)

1 that indicates that the dumbwaiter or elevator complies with this subchapter and  
2 any applicable rules promulgated under this subchapter.”
