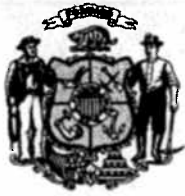

Current law requires the Department of Workforce Development (DWD) to establish a statewide workforce investment system to meet the employment, training, and educational needs of persons in this state; to plan, coordinate, administer, and implement a youth apprenticeship program and such other employment and education programs as the governor may assign to DWD; to make grants to persons providing employment and training activities to dislocated workers; and to award grants to public and private organizations for the development and implementation of workforce training programs for the training of both new and incumbent employees of businesses in this state.

This bill ~~transfers \$35,000,000 in fiscal year 2014-15 from~~ ^{decreases} the general purpose revenue supplemental appropriation to the Joint Committee on Finance, ~~to~~ the workforce training program grants appropriation to DWD, and requires DWD to allocate ~~that~~ amount transferred for all of the following:

1. Grants to technical colleges for the reduction of waiting lists for enrollment in programs and courses in high-demand fields, as determined by DWD.
2. Grants to school districts for partnerships with businesses to provide high school pupils with industry-recognized certifications in high-demand fields, as determined by DWD.

The bill requires DWD, in submitting information to the Department of Administration for purposes of the 2015-17 biennial budget act, to submit a dollar amount for the workforce training program grants appropriation as though the amount appropriated in fiscal year 2014-15 is the amount shown in the appropriation schedule minus the amount transferred to that appropriation under this bill. As a result, that amount transferred is not included in the base amount for the 2015-17 biennial budget.

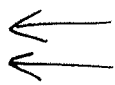
