## 2013 ASSEMBLY BILL 704

This bill increases funding for the Department of Transportation's state highway rehabilitation program.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

2 **SECTION 9245. Fiscal changes; Transportation**

3 (1) STATE HIGHWAY REHABILITATION. In the schedule under section 20.005 (3) of  
4 the statutes for the appropriation to the department of transportation under section  
5 20.395 (3) (cq) of the statutes, as affected by the acts of 2013, the dollar amount is  
6 increased by \$43,025,700 for the first fiscal year of the fiscal biennium in which this  
7 subsection takes effect to increase funding for the purposes for which the  
8 appropriation is made.
