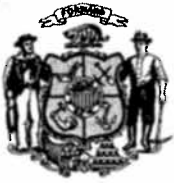

TO SENATE BILL 324**

in 2-7-14  
Today

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 2, line 1: delete “If <sup>✓</sup>Except as provided in par. (bb), if” and substitute
- 3 “If”.<sup>✓</sup>
- 4 **2.** Page 2, line 4: delete “<sup>✓</sup>6” and substitute “<sup>✓</sup>7”.<sup>✓</sup>
- 5 **3.** Page 2, line 4: after “election.” insert “<sup>✓</sup>No application may be received on a
- 6 legal holiday. An application made in person may only be received Monday to Friday
- 7 between the hours of 8 a.m. and 7 p.m. each day. A municipality may make available
- 8 no more than 45 hours each week for in-person absentee voting and shall specify the
- 9 hours in the notice under s. 10.01 (2) (e). The municipal clerk or an election official
- 10 shall witness the certificate for any such ballot cast.”.<sup>✓</sup>
- 11 **4.** Page 2, line 22: delete the material beginning with that <sup>✓</sup>line and ending with
- 12 page 3, line 4.<sup>✓</sup>
