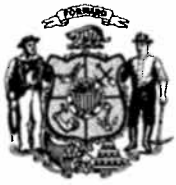

NOW

1 At the locations indicated, amend the amendment as follows:

2 ↓ 1. Page 1, line 2: delete lines 2 and 3 and substitute:

3 Frozen → "1d. Page 1, line 2: after "person" insert "and making an appropriation."

4 → 1m. Page 2, line 1: delete "If Except as provided in par. (bb), if" and substitute

5 "If". ↓

6 ↓ 2. Page 1, line 8: after "voting" insert "for any statewide election".

7 ↓ 3. Page 1, line 10: delete "such" and substitute "in-person absentee ballot".

8 4. Page 1, line 12: after that line insert:

9 "4d. Page 3, line 4: after that line insert:

10 ↓ SECTION 2d. 6.86 (1) (b) of the statutes is created to read: STEI

1           6.86 (1) (b) <sup>W</sup> A municipality may hire individuals to assist in receiving <sup>STET</sup>  
 2 absentee ballots in person for any statewide election during the period described  
 3 under par. (b) <sup>↓</sup> and shall compensate the individuals as provided under s. 7.03 (1) (a), <sup>✓</sup>  
 4 except that the state shall reimburse the municipality for 50 percent of the  
 5 compensation paid to such individuals during the 2014-15 fiscal year, not to exceed  
 6 compensation of 45 hours a week for each such individual. A municipality may  
 7 receive compensation under this paragraph if it notifies the department of revenue,  
 8 in the manner prescribed by the department, no later than July 1, 2015, of the  
 9 amount of compensation paid to individuals to assist in receiving absentee ballots in  
 10 person in the municipality for a statewide election. The department <sup>of revenue</sup> shall make  
 11 payments under this <sup>paragraph</sup> ~~subdivision~~ from the appropriation account under s. 20.566 (2)  
 12 (c).

**SECTION 2m.** 20.566 (2) (c) of the statutes is created to read:

14           20.566 (2) (c) *Absentee ballots in person.* A sum sufficient to reimburse  
 15 municipalities for compensation paid to individuals to assist in <sup>receiving</sup> ~~accepting~~ absentee  
 16 ballots in person, as provided under s. 6.86 (1) (b) <sup>it</sup> ".". <sup>✓</sup> <sup>STET</sup>
