

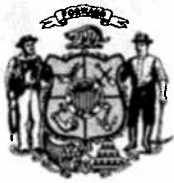

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 4: after "election." insert "Notwithstanding the other provisions
3 of this paragraph, if a municipality has any polling locations that ^{are} not in
4 compliance with the ^{federal} Americans with disabilities act, the municipal clerk may offer
5 hours for receiving absentee ballots in person without limitation to time and day."
