Per Kennedy's testimony on SB 324:

DRAFT a simple amendment that permits in-person absentee voting between 7 a.m. and 8 p.m. on weekdays, permits in-person absentee voting the two preceding Saturdays before an election, deletes the 45 hour weekly constraint on in-person absentee voting and deletes language that appointments for in-person absentee voting can only be made with the clerk and not a member of the clerk's staff.

Please send the information regarding the Milwaukee fix that Kennedy suggests to the Milwaukee Senators. I don't know if this was addressed in Lazich's amendment or not but they can figure that out.
