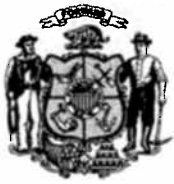

1 At the locations indicated, amend the amendment as follows:
2 1. Page 2, line 7: after "vacancies" insert "by giving first priority to appointing
3 or nominating qualified electors of the municipality for which an insufficient number
4 of nominees appears on the lists. If an insufficient number of qualified electors of the
5 municipality can be identified to fill the vacancies, the board of election
6 commissioners may appoint, and the mayor, president, or chairperson of the
7 municipality may nominate, qualified electors of a county within which the
8 municipality is located".
