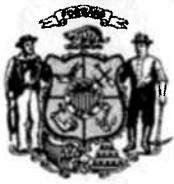

*How*

1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 1, line 3: before that line insert:

3 "SECTION 1g. 5.05 (5m)<sup>x</sup> of the statutes is created to read:

4 5.05 (5m) REPORT ON ELECTION FRAUDS, IRREGULARITIES, AND VIOLATIONS. The  
5 board shall annually report any information obtained under s. 7.15 (1) (g) to the  
6 appropriate standing committees of the legislature under s. 13.172 (3). The board  
7 shall include in the report required under this subsection recommendations to the  
8 legislature to address the suspected election frauds, irregularities, or violations  
9 identified in the report."

10 2. Page 1, line 3: delete "SECTION 1" and substitute "SECTION 1r".

11 3. Page 2, line 23: delete lines 23 and 24.
