

- 3 maintains another residence outside the home in this state".
- 4 2. Page 1, line 6: after "resides." insert "An elector who resides at a home but
- 5 does not wish to cast his or her vote at the home shall so indicate on his or her
- 6 absentee ballot application."
- 7 3. Page 1, line 11: after that line insert:
- 8 **"2n.** <sup>no B. 12pt</sup> Page 8, line 17: delete "If the elector maintains a residence outside the
- 9 facility or home," and substitute "If the elector resides at the facility or home or
- 10 maintains a residence in this state outside the facility or home,".
