At the locations indicated, amend the bill as follows:

"Section (1) (bb) of the statutes is created to read:

6.86 (1) (bb) If an application made in person under par. (b) is rejected for any reason, the clerk or election official shall attempt to contact the elector by telephone or electronically to inform the elector that his or her application made in person has been rejected and that, in order for the elector's vote to be counted, the elector must vote at his or her polling place on election day. The clerk or election official shall prepare a report of the rejected applications. The report shall indicate the times and dates on which the clerk or election official attempted to contact the elector and the reason for the rejected application. The clerk shall review the report and confirm the information contained therein and shall sign and date the report in the presence of at least one witness at the polling place. The clerk shall post the report on the municipality's Internet site or, if the municipality does not maintain an Internet site,
