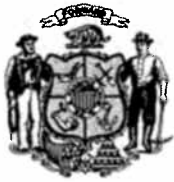

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 1, line 5: delete “For” and substitute “For Except as provided in par.
- 3 (jm), for”.
- 4 **2.** Page 1, line 5: delete “200 100” and substitute “200”.
- 5 **3.** Page 1, line 6: delete “400 200” and substitute “400”.
- 6 **4.** Page 1, line 7: after that line insert:
- 7 “SECTION 1m. 8.10 (3) (jm) of the statutes is created to read:
- 8 8.10 (3) (jm) For city offices in 2nd and 3rd class cities, not less than 100 nor
- 9 more than 200 electors for alderpersons who are not elected from aldermanic
- 10 districts.”.
