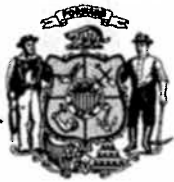

TO ASSEMBLY BILL 202

amendment 2,

1 At the locations indicated, amend the bill as follows:
on page 1, line 2, of the material inserted by assembly

2 1. Page 2, line 20: delete "not less than 3 feet from nor more than 8 feet from"
3 as inserted by assembly amendment 2, and substitute "not less than 6 feet from nor
4 more than 12 feet from".

5 2. Page 2, line 21: delete "not less than 3 feet from nor more than 8 feet from"
6 as inserted by assembly amendment 2, and substitute "not less than 6 feet from nor
7 more than 12 feet from".

Page 2, line 20: on page 1, line 3, of the material inserted by assembly amendment 2, delete "from nor more than 8 feet from" and substitute "from nor more than 12 feet from".

Page 2, line 21: on page 1, line 6, of the material inserted by assembly amendment 2, delete "8 feet from" and substitute "12 feet from".
