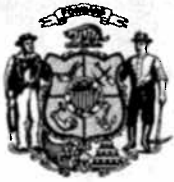

TO SENATE BILL 265

1 At the locations indicated, amend the bill as follows:

2 1. Page 3, line 1 after that line insert:

3 "SECTION 1m.7. 7.30 (4) (b) (intro.) of the statutes is amended to read:

4 7.30 (4) (b) (intro.) The 2 dominant parties, under sub. (2), are each responsible
5 for submitting a list of names from which all appointees to inspector positions, other
6 than appointees to inspector positions authorized under sub. (1) (b), shall be chosen.
7 Each person submitting the names of one or more nominees shall certify on his or her
8 list of nominations that the person has contacted each of the nominees whose name
9 appears on the list and that each nominee has agreed to serve as an election official.

10 The nominations shall be submitted as follows:".
