



**SENATE AMENDMENT 2,
TO SENATE BILL 267**

September 12, 2013 – Offered by Senator LAZICH.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 9: after “residence” insert “, the name of the entity or institution
3 that issued the identifying document, and, if the identifying document includes a
4 number that applies only to the individual holding that document, that number”.

5 **2.** Page 2, line 14: after “residence” insert “, the name of the entity or
6 institution that issued the identifying document, and, if the identifying document
7 includes a number that applies only to the individual holding that document, that
8 number”.

9 **3.** Page 2, line 15: before “issue” insert “shall”.

10 **4.** Page 3, line 2: after that line insert:

11 “**SECTION 2m.** 6.33 (1) of the statutes is amended to read:

12 6.33 (1) The board shall prescribe the format, size, and shape of registration
13 forms. All forms shall be printed on cards and each item of information shall be of

1 uniform font size, as prescribed by the board. The municipal clerk shall supply
2 sufficient forms to meet voter registration needs. The forms shall be designed to
3 obtain from each applicant information as to name; date; residence location; location
4 of previous residence immediately before moving to current residence location;
5 citizenship; date of birth; age; the number of a current and valid operator's license
6 issued to the elector under ch. 343 or the last 4 digits of the elector's social security
7 account number; whether the applicant has resided within the ward or election
8 district for at least 28 consecutive days; whether the applicant has been convicted of
9 a felony for which he or she has not been pardoned, and if so, whether the applicant
10 is incarcerated, or on parole, probation, or extended supervision; whether the
11 applicant is disqualified on any other ground from voting; and whether the applicant
12 is currently registered to vote at any other location. The form shall include a space
13 for the applicant's signature. Below the space for the signature, the form shall state
14 "Falsification of information on this form is punishable under Wisconsin law as a
15 Class I felony." The form shall include a space to enter the name of any special
16 registration deputy under s. 6.26 or 6.55 (6) or inspector, municipal clerk, or deputy
17 clerk under s. 6.55 (2) who obtains the form and a space for the deputy, inspector,
18 clerk, or deputy clerk to sign his or her name, affirming that the deputy, inspector,
19 clerk, or deputy clerk has accepted the form. The form shall include a space for entry
20 of the ward and aldermanic district, if any, where the elector resides and any other
21 information required to determine the offices and referenda for which the elector is
22 certified to vote. The form shall also include a space where the clerk may record an
23 indication of whether the form is received by mail; a space where the clerk may shall
24 record an indication of the type of identifying document submitted by the elector as
25 proof of residence ~~under s. 6.34,~~ the name of the entity or institution that issued the

1 identifying document, and, if the identifying document includes a number that
2 applies only to the individual holding that document, that number, whenever proof
3 of residence under s. 6.34 is required,; and a space where the clerk, for any applicant
4 who possesses a valid voting identification card issued to the person under s. 6.47 (3),
5 may record the identification serial number appearing on the voting identification
6 card. Each county clerk shall obtain sufficient registration forms for completion by
7 an elector who desires to register to vote at the office of the county clerk under s. 6.28
8 (4).”.

9 **5.** Page 3, line 18: after “residence” insert “, the name of the entity or
10 institution that issued the identifying document, and, if the identifying document
11 includes a number that applies only to the individual holding that document, that
12 number”.

13 **6.** Page 4, line 3: after “type of” insert “and the name of the entity or institution
14 that issued the”.

15 **7.** Page 4, line 18: after “elector” insert “and the name of the entity or
16 institution that issued the identifying document”.

17 **8.** Page 5, line 1: after “enter” insert “both”.

18 **9.** Page 5, line 1: after “residence” insert “and the name of the entity or
19 institution that issued the identifying document”.

20 **10.** Page 5, line 22: after “residence” insert “, the name of the entity or
21 institution that issued the identifying document, and, if the identifying document
22 includes a number that applies only to the individual holding that document, that
23 number”.

24 **11.** Page 6, line 8: after “enter” insert “both”.
