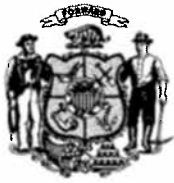

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 4, line 8: after that line insert:

3 “SECTION 3m. 77.79 of the statutes is amended to read:

4 **77.79 Relation to subch. III.** The provisions of subch. III; including those
5 related to exemptions, exceptions, exclusions and the retailers’ discount; that are
6 consistent with this subchapter, as they apply to the taxes under that subchapter,
7 apply to the taxes under this subchapter, except that the exemptions under ss. 77.52
8 (2) (a) 10. and 77.54 (5) (a) 1., 2., and 3. related to aircraft and aircraft parts do not
9 apply to the taxes under this subchapter.”
