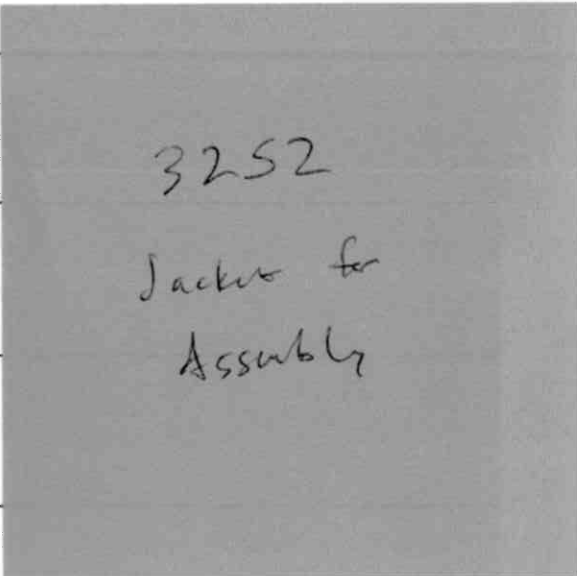

An Act **to affect** 2011 Wisconsin Act 32, section 9106 (1) (j) 1g. and 1r. of the statutes; **relating to:** an addition to the 2011-13 Authorized State Building Program.

Analysis by the Legislative Reference Bureau (proposed)

This bill amends the 2013-15 Authorized State Building Program to add one project for the Department of Veterans Affairs. The project involves the new construction of the John R. Moses Skilled Nursing Facility (with 200 replacement beds) at the Wisconsin Veterans Home at King. The project is financed with \$52,000,000 in restricted program revenue supported borrowing (to be replaced with federal funds) and \$28,000,000 in general fund supported borrowing authority.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
