Assumptions Used in Arriving at Fiscal Estimate

Under current law, any group or organization may apply to the Department of Transportation for designation as an authorized special group. If the application is approved, members may obtain special distinguishing license plates for certain vehicles that are owned or leased by special group members. A fee, in addition to the regular registration fee for the particular kind of vehicle, is charged for the issuance or reissuance of most special plates.

The proposed AB 244 will establish an authorized special group specifically enumerated in state law for persons interested in obtaining special plates displaying the words "In God We Trust." In addition to the regular vehicle registration fee, special group members must pay a \$15 fee for issuance or reissuance of these plates, which the fee is deposited in to the Veterans Trust Fund (VTF). This bill will also require special group members annually to include payment of \$25 that will provide funds for the care of residents of the Wisconsin Veterans Homes.

If enacted, a fee of \$15 shall be charged for the issuance or reissuance of a license plate for the special group and all moneys received in excess of the initial costs of production of the special group or \$23,700, whichever is less, shall be deposited in the VTF. Also, a voluntary payment of \$25 annually that is in addition to the \$15 fee shall be collected in connection with the issuance or renewal of a license plate issued for the special group displaying the words "In God We Trust"; all moneys received in excess of \$23,700 or of the initial cost of production, or whichever is less, shall be deposited into the Wisconsin Veterans Home's appropriation.

The fiscal effect of this bill is an increase in Program Revenue for the Department of Veterans Affairs.
