ASSEMBLY AMENDMENT 1,  
TO ASSEMBLY BILL 244

September 20, 2013 – Offered by Representative RIPP.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 8: after that line insert:

3 “SECTION 2g. 341.14 (6r) (b) 1m. of the statutes is renumbered 341.14 (6r) (b)  
4 1m. a. and amended to read:

5 341.14 (6r) (b) 1m. a. Upon receipt of contributions totaling an amount equal  
6 to the initial costs of production of the special group plates under par. (f) 61. or  
7 \$11,800, whichever is less, from Marquette University or other persons interested  
8 in the special group plates under par. (f) 61., the department shall commence any  
9 development work necessary to implement the provisions of par. (f) 61. and related  
10 provisions under this subsection and shall complete the development work within 6  
11 months of its commencement. The development work under this subdivision subd.  
12 1m. a. shall be funded only from the appropriation under s. 20.395 (4) (ch) from  
13 contributions received by the department for purposes of this subdivision subd. 1m.

1 a. If the department does not receive, by June 30, 2013, sufficient contributions to  
2 commence development work under this subdivision ~~subd. 1m. a.~~, the department  
3 may not commence development work under this subdivision ~~subd. 1m. a.~~ and shall  
4 promptly return to each contributor all contributions, less a transaction fee of no  
5 more than \$2.50 per contributor for costs associated with the return of contributions,  
6 received by the department for purposes of this subdivision ~~subd. 1m. a.~~ If the  
7 department receives contributions in excess of the amount necessary to commence  
8 development work under this subdivision ~~subd. 1m. a.~~, the department shall  
9 discontinue receiving contributions under this subdivision ~~subd. 1m. a.~~ and  
10 promptly return to each contributor all contributions, less a transaction fee of no  
11 more than \$2.50 per contributor for costs associated with the return of contributions,  
12 received by the department after the department had received sufficient  
13 contributions. No contribution received by the department under this subdivision  
14 ~~subd. 1m. a.~~ may be applied to any fee established under subd. 2. The department  
15 may not issue any special group plates under par. (f) 61. until the department has  
16 completed the development work specified in this subdivision ~~subd. 1m. a.~~

17 **SECTION 2r.** 341.14 (6r) (b) 1m. d. of the statutes is created to read:

18 341.14 (6r) (b) 1m. d. Upon receipt of contributions totaling an amount equal  
19 to the department's final estimate of the initial costs of production of the special  
20 group plates under par. (f) 62. or \$23,700, whichever is less, from persons interested  
21 in the special group plates under par. (f) 62., the department shall commence any  
22 development work necessary to implement the provisions of par. (f) 62. and related  
23 provisions under this subsection and shall complete the development work within  
24 one year of its commencement. As soon as possible, the department shall post notice  
25 on the department's Internet site of its final estimate of the initial costs of production

1 of the special group plates under par. (f) 62. The development work under this subd.  
2 1m. d. shall be funded only from the appropriation under s. 20.395 (4) (ch) from  
3 contributions received by the department for purposes of this subd. 1m. d. If the  
4 department does not receive, by June 30, 2017, sufficient contributions to commence  
5 development work under this subd. 1m. d., the department may not commence  
6 development work under this subd. 1m. d. and shall promptly return to each  
7 contributor all contributions, less a transaction fee of no more than \$2.50 per  
8 contributor for costs associated with the return of contributions, received by the  
9 department for purposes of this subd. 1m. d. If the department receives  
10 contributions in excess of the amount necessary to commence development work  
11 under this subd. 1m. d., the department shall discontinue receiving contributions  
12 under this subd. 1m. d. and promptly return to each contributor all contributions,  
13 less a transaction fee of no more than \$2.50 per contributor for costs associated with  
14 the return of contributions, received by the department after the department had  
15 received sufficient contributions. No contribution received by the department under  
16 this subd. 1m. d. may be applied to any fee established under subd. 9. b. The  
17 department may not issue any special group plates under par. (f) 62. until the  
18 department has completed the development work specified in this subd. 1m. d.”.

19 **2.** Page 3, line 14: delete the material beginning with “in” and ending with  
20 “less,” on line 15.

21 **3.** Page 5, line 17: delete the material beginning with that line and ending with  
22 page 6, line 6.
