Hi, Marc –

I am requesting a draft amendment to AA3 to SB 338.
The amendment will be needed prior to floor action on Thursday, February 20th.

The amendment would make it clear that a community could rely on current law to create a TID in recently annexed territory or, alternatively, could use the new provision created in AA3 (the portion of which was originally in AB 747) which provides an exemption from the 12% limit, but also imposes several limitations on the TID.
