- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 2, line 15: delete “recording device, as defined in s. 943.49 (1) (c)” and
- 3 substitute “device that, in analog, digital, or other form, gathers, records, or
- 4 transmits a sound or image”.
- 5 **2.** Page 3, line 3: after “use of a drone” insert “in a public place or”.
- 6 **3.** Page 3, line 13: delete “sells, transports, manufactures, possesses, or”.
- 7 **4.** Page 3, line 14: after “felony.” insert “This subsection does not apply to a
- 8 member of the U.S. armed forces or national guard acting in his or her official
- 9 capacity.”.
- 10 **5.** Page 3, line 16: after “175.55 (1) (a),” insert “with the intent”.
- 11 **6.** Page 3, line 17: after “place” insert “or location”.
