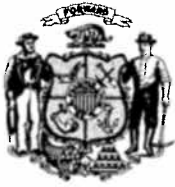
Eric,

1 AN ACT to create 125.09 (7) of the statutes; relating to: prohibiting  
2 municipalities from providing alcohol beverages retailers with identification  
3 scanners.

**Analysis by the Legislative Reference Bureau**

This bill prohibits municipalities from providing to alcohol beverages retail licensees any device capable of scanning a driver's license or identification card issued by the Department of Transportation.

**The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:**

4 SECTION 1. 125.09 (7) of the statutes is created to read:  
5 125.09 (7) MUNICIPALITY PROVIDING IDENTIFICATION SCANNERS. No municipality  
6 may provide, to any retail licensee under this chapter, any device capable of scanning  
7 an official identification card, as defined in s. 125.085 (1) (a) and (b).
