

Per our conversation, I'd like to request an amendment to SB 588 and AB 799 to do the following:

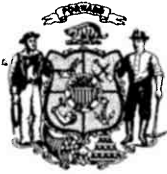
- Delete Section 8 of the bill; remove all references to required driver safety education and examination
