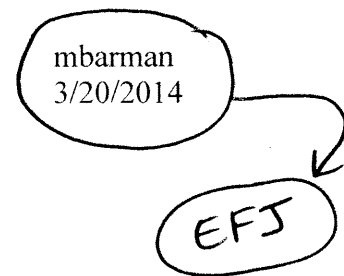



2 1. Page 1, line 3: delete "pedestrians crossing".

3 2. Page 1, line 4: delete "tracks" and substitute "crossings".

4 3. Page 2, line 1: before that line insert:

5 "SECTION 1g. 192.29 (6) of the statutes is created to read:

6 192.29 (6) CONTACT INFORMATION AT PRIVATE CROSSINGS. A railroad company shall
7 post a notice containing a telephone number at which a person may contact the
8 company at each private traveled grade crossing."

9 4. Page 2, line 1: delete "SECTION 1" and substitute "SECTION 1m".
