4 **2.** Page 3, line 22: after that line insert:

5 "SECTION 3g. 346.63 (2) (c) of the statutes is created to read:

6 346.63 (2) (c) In this subsection, "injury" has the meaning given for "substantial  
7 bodily harm" in s. 939.22 (38)."

8 **SECTION 3r.** 346.63 (6) (e) of the statutes is created to read:

9 346.63 (6) (e) In this subsection, "injury" has the meaning given for "substantial  
10 bodily harm" in s. 939.22 (38)."

11 **3.** Page 5, line 14: delete "section" and substitute "sections 346.63 (2) (c) and  
12 (6) (e) and".
