Hello Aaron,

Per my phone message, Rep. Bernard Schaber would like to have an amendment drafted to AB 258, LRB 1480/1, that does the following things:

- Requires that all fees paid under 84.305(5) Section 13 of the bill, be used by the Department for the purposes of replanting vegetation along highway right-of-ways.
- In the section on cross vista viewing, the new definition of "viewing zone" in section 3, I would like to make an exception, namely that the viewing zone opposite the direction of travel from which the sign face is visible and intended to be viewed is not applicable if there is a vegetated median in between the sign and the lane of opposite direction travel.
- Delete Section 8, restoring 84.305(5)(ar) of the statutes.

1           ~~SECTION 3m.~~<sup>x</sup> 84.305 (1) (i) of the statutes is renumbered 84.305 (1) (i) (intro.)  
2 and amended to read:

3           84.305 (1) (i) (intro.) "Viewing zone" means, with respect to a sign, the area  
4 commencing at the point on the main-traveled way of the highway nearest the sign  
5 for the direction of travel for which the sign face is oriented and extending, in a  
6 direction opposite of the direction of travel in, as follows:

7           1. In the nearest through traffic lanes, in a line along the highway parallel to  
8 the highway pavement edge for a distance of 1,000 feet."

9           6. Page 3, line 14: before that line insert:

10           ~~SECTION 3p.~~<sup>x</sup> 84.305 (1) (i) 2. of the statutes is created to read:

11           84.305 (1) (i) 2. If the sign face is visible and intended to be viewed from the  
12 traffic lanes for the direction of travel opposite to that of the lanes under subd. 1. and  
13 there is no median containing vegetation between the traffic lanes under this  
14 subdivision and those under subd. 1., then, in the lanes under this subdivision, in a  
15 line along the highway pavement edge for a distance of 1,000 feet."

16           7. Page 4, line 13: delete "~~Subject to par. (ar), each~~ Each" and substitute  
17 "Subject to par. (ar), each".

18           8. Page 4, line 19: delete that line.

19           9. Page 5, line 17: after "(d)." insert "All moneys received by the department  
20 under this subdivision shall be deposited into the transportation fund and credited  
21 to the appropriation under s. 20.395 (3) (jt)."
