"Solicit" means to directly advertise or market through writing or graphics and via mail, telefax or electronic mail to an individually identified person, residence or business location. "Solicit" does not include any of the following: (a) Communicating through a mass advertisement, including a catalog, a radio or television broadcast or a website; (b) Communicating via telephone, mail, or electronic communication, if initiated by the consumer; (c) Advertising and marketing to those with who the solicitor has a pre-existing business relationship.
