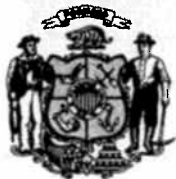

SENATE AMENDMENT,

TO SENATE BILL 596

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 3: before that line insert:

3 **"SECTION 1g.** 23.115 (3) of the statutes is amended to read:

4 23.115 (3) Subsection (2) does not apply to snowmobile trails on land under the
5 control of the department that are maintained by snowmobile clubs or other
6 nonprofit organizations or to water trails under s. 23.175 (2) (a)."
