1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 1: delete "solicit input from" and substitute "work directly with
3 persons on the list maintained under par. (c) and with". *INS A (from amendment)*

4 **2.** Page 3, line 2: delete the material beginning with "to determine" and ending
5 with "175.51" on line 3 and substitute "to develop criteria for law enforcement officers
6 to use to identify reports of missing adults at risk that are appropriate to disseminate
7 under s. 175.51, to determine the most effective methods and guidelines for the
8 persons on the list maintained under par. (c) to use to broadcast or make public
9 reports of missing adults at risk,".

10 **3.** Page 3, line 7: after "(b) 2." insert "A person on the list shall broadcast or
11 make public reports of missing adults at risk that are disseminated to the person
12 under s. 175.51 (2).".
