**ASSEMBLY AMENDMENT,
TO ASSEMBLY BILL 710**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 16: delete “(a).” and substitute “(b) 1. The department may not
3 charge a fee to any person who receives information under sub. (1) (b) 2.”.

4 **2.** Page 3, line 1: delete “solicit input from” and substitute “work directly with
5 persons on the list maintained under par. (c) and with government agencies,
6 broadcasters, and public and”.

7 **3.** Page 3, line 2: delete the material beginning with “to determine” and ending
8 with “175.51” on line 3 and substitute “*adults at risk* to develop criteria for law enforcement officers
9 to use to identify reports of missing adults at risk that are appropriate to disseminate
10 under s. 175.51, to determine the most effective methods and guidelines for the
11 persons on the list maintained under par. (c) to use to broadcast or make public
12 reports of missing adults at risk.”.

13 **4.** Page 3, line 10: delete “who is at least 65 years of age and”
individual and substitute
“adult”
