



**ASSEMBLY AMENDMENT 1,
TO ASSEMBLY BILL 208**

September 20, 2013 – Offered by Representative RIPP.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 1: before that line insert:

3 “**SECTION 1g.** 341.14 (6r) (b) 1m. of the statutes is renumbered 341.14 (6r) (b)
4 1m. a. and amended to read:

5 341.14 **(6r)** (b) 1m. a. Upon receipt of contributions totaling an amount equal
6 to the initial costs of production of the special group plates under par. (f) 61. or
7 \$11,800, whichever is less, from Marquette University or other persons interested
8 in the special group plates under par. (f) 61., the department shall commence any
9 development work necessary to implement the provisions of par. (f) 61. and related
10 provisions under this subsection and shall complete the development work within 6
11 months of its commencement. The development work under this subdivision subd.
12 1m. a. shall be funded only from the appropriation under s. 20.395 (4) (ch) from
13 contributions received by the department for purposes of this subdivision subd. 1m.

1 a. If the department does not receive, by June 30, 2013, sufficient contributions to
2 commence development work under this subdivision ~~subd. 1m. a.~~, the department
3 may not commence development work under this subdivision ~~subd. 1m. a.~~ and shall
4 promptly return to each contributor all contributions, less a transaction fee of no
5 more than \$2.50 per contributor for costs associated with the return of contributions,
6 received by the department for purposes of this subdivision ~~subd. 1m. a.~~ If the
7 department receives contributions in excess of the amount necessary to commence
8 development work under this subdivision ~~subd. 1m. a.~~, the department shall
9 discontinue receiving contributions under this subdivision ~~subd. 1m. a.~~ and
10 promptly return to each contributor all contributions, less a transaction fee of no
11 more than \$2.50 per contributor for costs associated with the return of contributions,
12 received by the department after the department had received sufficient
13 contributions. No contribution received by the department under this subdivision
14 ~~subd. 1m. a.~~ may be applied to any fee established under subd. 2. The department
15 may not issue any special group plates under par. (f) 61. until the department has
16 completed the development work specified in this subdivision ~~subd. 1m. a.~~

17 **SECTION 1m.** 341.14 (6r) (b) 1m. f. of the statutes is created to read:

18 341.14 **(6r)** (b) 1m. f. Upon receipt of contributions totaling an amount equal
19 to the department's final estimate of the initial costs of production of the special
20 group plates under par. (f) 62. or \$11,800, whichever is less, from persons interested
21 in the special group plates under par. (f) 62., the department shall commence any
22 development work necessary to implement the provisions of par. (f) 62. and related
23 provisions under this subsection and shall complete the development work within
24 one year of its commencement. As soon as possible, the department shall post notice
25 on the department's Internet site of its final estimate of the initial costs of production

1 of the special group plates under par. (f) 62. The development work under this subd.
2 1m. f. shall be funded only from the appropriation under s. 20.395 (4) (ch) from
3 contributions received by the department for purposes of this subd. 1m. f. If the
4 department does not receive, by June 30, 2017, sufficient contributions to commence
5 development work under this subd. 1m. f., the department may not commence
6 development work under this subd. 1m. f. and shall promptly return to each
7 contributor all contributions, less a transaction fee of no more than \$2.50 per
8 contributor for costs associated with the return of contributions, received by the
9 department for purposes of this subd. 1m. f. If the department receives contributions
10 in excess of the amount necessary to commence development work under this subd.
11 1m. f., the department shall discontinue receiving contributions under this subd. 1m.
12 f. and promptly return to each contributor all contributions, less a transaction fee of
13 no more than \$2.50 per contributor for costs associated with the return of
14 contributions, received by the department after the department had received
15 sufficient contributions. No contribution received by the department under this
16 subd. 1m. f. may be applied to any fee established under subd. 2. The department
17 may not issue any special group plates under par. (f) 62. until the department has
18 completed the development work specified in this subd. 1m. f.”.

19 **2.** Page 2, line 1: delete “**SECTION 1**” and substitute “**SECTION 1r**”.

20 **3.** Page 2, line 12: delete the material beginning with that line and ending with
21 page 3, line 6.
