1 At the locations indicated, amend the bill as follows:

2 **1.** Page 8, line 12: delete the material beginning with "his" and ending with
3 "was completed," on line 14 and substitute "the confinement portion of his or her
4 sentence, if the applicant is serving a bifurcated sentence, or has been released from
5 prison to parole or released upon the completion of his or her sentence; and 3 years
6 have elapsed since the date on which the confinement portion was completed or the
7 applicant was released,".
