all Thanks for your time on the telephone. Here's a list of desired Jorgensen amendments to SB 497, as best I can describe them.

Amendment 1: Define "repeat offenders" as businesses which have repeated the same rule violation more than three times.

Amendment 2: Define "substantial financial gain" to mean if the business violation netted more than what the potential fine may be.

Amendment 3: Strike "imminent" from the phrase "imminent public danger" and substitute the word "serious."

Amendment 4: Eliminate all references to agency discretion on considering "ability to pay" when determining a penalty.

Amendment 5: Sunset this law one year after effective date.

Amendment 6: Require state agencies to annually publish a public report on instances in which they utilized discretion in penalizing businesses.

Amendment 7: Bundle Amendments 1-6 into a substitute amendment.

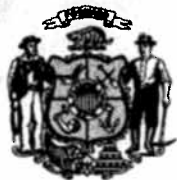
