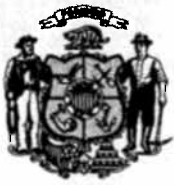

Hi, Gordon, we have one change to the amendments to the foster care bills (a1536 and a1537) regarding RCC's. We need the amendment to require DCF to pay for the RCC placement costs, rather than having it simply allow DCF to do so:

1. Add a provision that the Department is responsible for paying the placement costs for a youth aged 18 or older who is in out-of-home care under an extended court order or a voluntary transition-to-independent living agreement under the Section 18 (s. 48.366) of AB 570 and SB 451 and who is in a residential care center. The Department shall use funding from appropriation 20.437(1)(dd) and (1)(pd) for this purpose.
