Hi Gordon--

Sen. Darling's office is now asking for an amendment to SA 1 (LRBa1537/2) to SB 451. It will move most (but not all) of the money from the Joint Finance Committee's appropriation to 3 appropriations in DCF and 1 in DOC as follows:

Reduce 20.865(4)(a) by \$907,100 in 2014-15.

Increase 20.410(3)(cd) by \$83,400 in 2014-15.

Increase 20.437(1)(b) by \$351,300 in 2014-15.

Increase 20.437(1)(cx) by \$177,600 in 2014-15.

Increase 20.437(1)(dd) by \$294,800 in 2014-15.
