SENATE AMENDMENT 2, TO SENATE BILL 451

March 18, 2014 – Offered by Senator Erpenbach.

At the locations indicated, amend the bill as follows:

2	1. Page 2, line 13: after "programs," insert "copayments, deductibles, or
3	coinsurance for oral chemotherapy and injected or intravenous chemotherapy,".
4	2. Page 4, line 8: after that line insert:

If a city, including a 1st class city, or a village provides health care benefits under its home rule power, or if a town provides health care benefits, to its officers and employees on a self-insured basis, the self-insured plan shall comply with ss. 49.493 (3) (d), 631.89, 631.90, 631.93 (2), 632.746 (10) (a) 2. and (b) 2., 632.747 (3), 632.798, 632.85, 632.853, 632.855, 632.867, 632.87 (4), (5), and (6), 632.885, 632.89, 632.895 (9) to (17), 632.896, and 767.513 (4).

Every voluntary nonprofit health care plan operated by a cooperative association organized under s. 185.981 shall be exempt from chs. 600 to 646, with the exception of ss. 601.04, 601.13, 601.31, 601.41, 601.42, 601.43, 601.44, 601.45, 611.26, 611.67, 619.04, 623.11, 623.12, 628.34 (10), 631.17, 631.89, 631.93, 631.95, 632.72 (2), 632.745 to 632.749, 632.775, 632.79, 632.795, 632.798, 632.85, 632.853, 632.855, 632.867, 632.87 (2), (2m), (3), (4), (5), and (6), 632.885, 632.89,

6	Limited service health organizations, preferred provider plans, and defined network
7	plans are subject to s. 632.867.
8	Section 61p. 632.867 of the statutes is created to read:
9	632.867 Oral and injected chemotherapy. (1) Definitions. In this section:
10	(a) "Chemotherapy" means drugs and biologics that kill cancer cells directly,
11	including antineoplastics, biologic response modifiers, hormone therapy, and
12	monoclonal antibodies, and that are used to do any of the following:
13	1. Cure a specific cancer.
14	2. Control tumor growth when cure is not possible.
15	3. Shrink tumors before surgery or radiation therapy.
16	4. Destroy microscopic cancer cells that may be present after a tumor is
17	removed by surgery to prevent a cancer recurrence.
18	(b) "Disability insurance policy" has the meaning given in s. 632.895 (1) (a).
19	(c) "Self-insured health plan" has the meaning given in s. 632.85 (1) (c).
20	(2) Copayment, deductible, or coinsurance requirements; limitations. (a) A
21	disability insurance policy that covers injected or intravenous chemotherapy and
22	oral chemotherapy, or a self-insured health plan that covers injected or intravenous
23	chemotherapy and oral chemotherapy, may not require a higher copayment,

deductible, or coinsurance amount for oral chemotherapy than it requires for

- injected or intravenous chemotherapy, regardless of the formulation or benefit category determination by the policy or plan.
- (b) A disability insurance policy or a self-insured health plan may not comply with par. (a) by increasing the copayment, deductible, or coinsurance amount required for injected or intravenous chemotherapy that is covered under the policy or plan.".
 - **6.** Page 59, line 16: after that line insert:

"SECTION 118n. Initial applicability.

- (1c) The treatment of sections 40.51 (8) and (8m), 66.0137 (4), 120.13 (2) (g), 185.983 (1) (intro.), 609.837, and 632.867 of the statutes first applies to all of the following:
- (a) Except as provided in paragraphs (b) and (c), disability insurance policies that are issued or renewed, and governmental or school district self-insured health plans that are established, extended, modified, or renewed, on the effective date of this paragraph.
- (b) Disability insurance policies covering employees who are affected by a collective bargaining agreement containing provisions inconsistent with this act that are issued or renewed on the earlier of the following:
 - 1. The day on which the collective bargaining agreement expires.
- 20 2. The day on which the collective bargaining agreement is extended, modified, or renewed.
 - (c) Governmental or school district self-insured health plans covering employees who are affected by a collective bargaining agreement containing
