

ASSEMBLY AMENDMENT,  
TO ASSEMBLY BILL 674

1 At the locations indicated, amend the bill as follows:

2 1. Page 3, line 17: after that line insert:

3 "SECTION 6t. 48.61 (3) of the statutes is amended to read:

4 48.61 (3) To provide appropriate care and training for children in its legal or  
5 physical custody and, if licensed to do so, to place children in licensed foster homes  
6 and licensed group homes as permitted under s. 48.63 (1) (a), in shelter care facilities  
7 as permitted under s. 48.63 (1) (b), and in the homes of guardians as permitted under  
8 s. 48.977 (2).".
