Hi Liz,

I have a couple of questions.

1. The materials initially provided by DOT included several "clean up" changes related to the local bridge program. (See AB-262 bill sections 57 to 60.) After this part was drafted, committee members suggested also increasing the \$5,000,000 threshold to \$16,000,000 (bill section 56). Do you want this amendment to take out only bill section 56 referring to the \$5M to \$16M increase, or do you want this amendment to take out all bill sections referring to the local bridge program (bill sections 56 to 60)?
2. It looks like the last amendment I drafted was offered as AA1 to AB-262, so I cannot modify that amendment. Do you want a new amendment to replace AA1 that includes the same content as AA1 plus this change? Or do you want a new amendment with only this change that could be offered in addition to AA1?

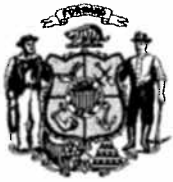
Hey Aaron,
