(h) *Books of account.* Keep all of the accounts of the county and all books of account as the board directs. Books of account shall be maintained on a calendar year basis, which shall be the fiscal year in every county. The board may create an office of county audit under s. 59.47 (2), in which case, the clerk may have access to the books, accounts, bills, vouchers as often as may be necessary to perform the duties required under this section and the duties described in various other statutes. **i.e.59.06...etc. MAY NEED LAWYER LANGUAGE**

Hi Marc, I left you a voice mail but thought I'd follow that up by trying to explain the changes we're looking to have drafted as an amendment to AB ~~631~~.

613

1. Sect. 4
 - a. Put back current statute language in this section.... EXCEPT for the last part of the provision in the section dealing with the board meeting to provide a salary for a deputy(ies). In this area we mirrored the language from the Co. Treasures language in 59.25

2. Sect. 11
 - a. Remove the provision in AB 631 that gives clerks access to financial records even in the case where an office of the auditor is established.
 - b. Instead, refer clerk's responsibility in financial matters to ss. 59.23 (2) (h).
 - c. Rep. Bernier asked if 59.06 might also need to be captured in this section.

Let me know if these instructions are clear. Maybe we should make this a 'P' draft for now. Give me a call to discuss.

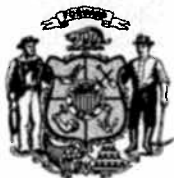

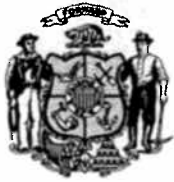
